

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- A Resolution entitled, "Approval for Thunder Butte Petroleum Services, Inc. and Chairman Fox, to Advance Negotiations with Ventech Engineers International LLC to Develop a Contract to Develop the MHA Nation Clean Fuels Refinery Project"
- WHEREAS, The Mandan Hidatsa and Arikara Nation (the "MHA Nation" or "Nation"), having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act having adopted a Constitution and By-laws under said Act; and
- WHEREAS, The Constitution of the MHA Nation generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Nation and of the enrolled members thereof; and
- **WHEREAS,** Article III, Section 1 of the Constitution of the MHA Nation provides that the Tribal Business Council is the governing body of the Nation; and
- WHEREAS, Article VI, Section 5(1) of the Constitution of the MHA Nation provides that the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Business Council; and
- WHEREAS, The MHA Nation has dedicated several years to the development of the MHA Nation Clean Fuels Refinery Project (the "Project"); and
- WHEREAS, The Tribal Business Council approved the Articles of Incorporation of Thunder Butte Petroleum Services, Inc. ("Thunder Butte") pursuant to the Tribal Business Corporation Act, thereby validly establishing Thunder Butte on November 28, 2011, through Tribal Business Council Resolution 11-127, for the purpose of creating the legal entity to operate the Project; and
- **WHEREAS,** Thunder Butte has taken direction from the Tribal Business Council to establish a thorough and viable structure for the development, financing, and operation of the Project; and
- WHEREAS, Thunder Butte has allocated significant time and resources examining the feasibility of various organizational structures for the Project; and
- WHEREAS, Thunder Butte has been negotiating terms of an Engineering, Procurement, Manufacturing and Site Assistance Agreement with Ventech Engineers



- International LLC ("Ventech") to provide the engineering, procurement, manufacturing and site assistance of a 20,000 barrel per day modular refinery; and
- WHEREAS, Ventech is a global leader in the design and construction of new modular refineries and has both significant experience and a proven track record of developing refineries that will benefit Thunder Butte and the MHA Nation; and
- **WHEREAS**, Ventech has proposed to Thunder Butte an organizational structure for the Project that addresses financing, organization, and operations in a feasible manner; and
- **WHEREAS**, Ventech is willing to become an equity partner with Thunder Butte and jointly develop and construct the Project; and
- WHEREAS, The Tribal Business Council finds it in the best interest of the MHA Nation for Thunder Butte and the Chairman of the MHA Nation (hereafter "Chairman") to negotiate the terms and conditions of a guaranteed maximum price contract with Ventech in which the MHA Nation and Ventech will develop the Project as joint owners whereby the MHA Nation will be a majority owner and Ventch will be a minority owner with the exact percentages to be negotiated in the final agreement.
- NOW THEREFORE BE IT RESOLVED, the Business Council hereby authorizes and approves Thunder Butte and the Chairman to negotiate the terms and conditions of a guaranteed maximum price contract with Ventech in which the MHA Nation and Ventech will develop the Project as joint owners whereby the MHA Nation will be a majority owner and Ventech shall be a minority owner with the exact percentages negotiated as set forth in the final agreement.
- **BE IT FURTHER RESOLVED,** that the agreement shall be presented to the Tribal Business Council for final approval.
- **BE IT FINALLY RESOLVED,** that the Chairman is hereby authorized to take such further actions as are necessary to carry out the terms and intent of this Resolution.
