

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- A Resolution Entitled: "Budget Modification White Shield School Project"
- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and
- **WHEREAS,** The Constitution of the Three Affiliated Tribe generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Article VI, Section 5 (1) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies; and
- **WHEREAS,** The White Shield Segment had previously approved projects to be funded by the Segment's FY2015 appropriation including the White Shield School project; and
- **WHEREAS,** The prior approved budget for the White Shield School project was determined to be \$13,644,525.62; and
- WHEREAS, In order to meet the design specifications for the educational needs of the White Shield Segment, the total White Shield School project budget (guaranteed maximum price) is \$17,366,816.05; and
- **WHEREAS**, An additional appropriation of \$3,722,290.43 in the current FY 2015 budget to complete the White Shield School project for the 2016-2017 school year; and
- **WHEREAS**, the Tribal Business Council has considered this additional budget request and finds it necessary and in the best interests of the White Shield Community.
- NOW, THEREFORE, BE IT RESOLVED THAT, The Tribal Business Council of the Three Affiliated Tribes hereby approves an additional appropriation of \$3,722,290.43 to the White Shield Segment for the White Shield School Project; and
- **BE IT FURTHER RESOLVED,** The Tribal Business Council of the Three Affiliated Tribes further approves the total budget for the White Shield School project in the amount of \$17,366,816.05; and



BE IT FINALLY RESOLVED, upon finalization of the White Shield School Construction Contract, the Tribal Chairman and Tribal Treasurer shall be authorized to take such action to make available the additional funding as approved under this Resolution.
