



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

**A Resolution entitled: “Approval of Site Work Contract for White Shield Segment Projects–DJR Construction Management LLC of 333 Washington Ave. North, Suite 300, Minneapolis, MN 55401”**

**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and

**WHEREAS,** The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

**WHEREAS,** Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

**WHEREAS,** Article VI, Section 5(1) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials of the Reservation; and

**WHEREAS,** The Tribal Business Council had previously approved a segment budget for all projects in the amount of \$15,000,000.00 for FY2015; and

**WHEREAS,** The White Shield Segment has negotiated a final contract including amendments and related maximum price contracts for all site work (including utilities) for all the White Shield Segment Projects including: the White Shield K-12 School, the White Shield Community Center and the White Shield Head Start; and

**WHEREAS,** the total amount for all site work is \$9,034,368.48 and individual breakdowns for each project are:

White Shield K-12 School	\$2,252,359.00
White Shield Community Center	\$1,384,571.84
White Shield Head Start	\$ 869,688.17
Utility Services (all)	\$3,805,000.00
Management Fee (5%)	\$ 451,718.42
Contingency Reserve	\$ 271,031.05

**WHEREAS,** The Tribal Business Council has reviewed this contract including amendments and related maximum price contracts, and finds it in the best interests of the White Shield Segment.



**THEREFORE BE IT RESOLVED**, that the Tribal Business Council of the Three Affiliated Tribes hereby approves the Site Work Construction Contract for the White Shield Segment Projects with DJR Construction Management LLC for the total maximum price of \$9,034,368.48; and


**BE IT FURTHER RESOLVED**, the Tribal Chairman is hereby specifically authorized to execute the agreement as approved by the Tribal Business Council.
