

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Almit Breuer - Farm Lease on Tribal land"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and
- WHEREAS, Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and
- WHEREAS, Article IX Sections 1 and 3 of the Constitution provides that the Tribal Business Council has the authority to manage and lease or otherwise deal with tribal lands and resources; and
- WHEREAS, Leases tribal trust land require the consent of the Tribal Business Council pursuant to federal and tribal law; and
- WHEREAS, Application for Farm Lease for Mr. Almit Breuer, 6351 14<sup>th</sup> Street NW, Garrison, ND 58540; and
- **WHEREAS,** The applications for Farm Lease described herein have been reviewed and recommended for approval in accordance with the Three Affiliated Tribes' approved procedure for authorizing leasing on tribal land; and
- WHEREAS, The Tribal Business Council finds it appropriate to authorize the Farm Lease on Allotment Number 142A described herein.
- **NOW THEREFORE BE IT RESOLVED,** the Business Council hereby consents to the following Farm Lease:
  - Bureau of Indian Affairs Lease Number 2014211519, on Allotment Number 142A, containing 160 acres, with 52 acres cultivated, at a rate of \$32.00 an acre. For a term of Five (5) years, beginning the first day of January, 2015, to be completed and ended on the 31<sup>st</sup> day of December, 2019, subject to the conditions hereinafter set forth. Allotment Number 142A, in the SE1/4, Section 32, T. 148 N. R, 88 W., McLean County, 5<sup>th</sup> Principal Meridian of North Dakota, containing an undivided interest of 66.31%, more or less, as more particularly described in Appendix A.1.



**BE IT FINALLY RESOLVED,** that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.

## CERTIFICATION
