

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Consent to Right-of-Way across Tribal land Submitted by Whiting Oil and Gas Corporation to Add Four Wells to the Skunk Creek 4-10-11-8H Well Pad."

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and
- WHEREAS, Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and
- WHEREAS, Article IX Sections 1 and 3 of the Constitution provides that the Tribal Business Council has the authority to manage and lease or otherwise deal with tribal lands and resources; and
- WHEREAS, Leases and Rights of Way (ROWs) across tribal trust land require the consent of the Tribal Business Council pursuant to federal and tribal law; and
- WHEREAS, Applications for Rights of Way on Tribal Land are subject to the requirements of tribal law, including Resolution No. 14-071-VJB (MHA Nation Application for Rights of Way and Use of Right of Way), Resolution No. 14-089-VJB (MHA Nation Pipeline Right-of-Way Terms and Conditions), and Resolution No. 15-045-LKH (Establishing a Procedure for the Approval of Leases, Rights of Way, Setback Variances and Permissions to Survey on Tribal Land); and
- WHEREAS, The applications for ROW(s), submitted by Whiting Oil and Gas Corporation ("Whiting") described herein have been reviewed and recommended for approval in accordance with the MHA Nation's approved procedure for authorizing ROWs on tribal land; and
- WHEREAS, On November 16, 2015, at a duly held meeting of the Natural Resources Committee, the MHA Nation Energy Division recommended for approval Whiting's ROW request to add four (4) new wells to the Skunk Creek 4-10-11-8H Well Pad, and the Natural Resources Committee approved Whiting's ROW request and forwarded it to the Tribal Business Council for final action.



- WHEREAS, The Tribal Business Council finds it appropriate to authorize and consent to the Right-of-Way described herein.
- NOW THEREFORE BE IT RESOLVED, the Tribal Business Council hereby grants consent to a Right-of-Way Across the following tribal lands, but only subject to Whiting Oil and Gas Corporation's agreement to and execution of the MHA Right-of-Way Application and applicable Terms and Conditions and payment of ROW fees, approved and authorized in Resolution No. 14-089-VJB:
 - Whiting Oil and Gas Corporation to add four additional wells (Skunk Creek 4-10-11-1H, Skunk Creek 4-10-11-1H3, Skunk Creek 4-10-11-8H3 & Skunk Creek 4-10-11-8HA) to the Skunk Creek 4-10-11-8H Well Pad, across certain tribal lands on Allotment 301 T1756, consisting of 100% tribal interest, in Section 10, Township 148 North, Range 93West, Dunn County, North Dakota, as more particularly described in Appendix A.1.
- **BE IT FINALLY RESOLVED,** that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.
