

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled: "Approving the Purchase of 77.5 Acres from the Little Owl Family"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Business Council has determined that it is in the best interest of the Tribes to purchase certain lands in the Twin Buttes Segment for community development purposes; and
- WHEREAS, A portion of the land to be purchased for community development from the Little Owl Family members Adrienne Long Soldier and Clarissa S. Takeshorse. 2.5 acres encompassing burial grounds will be retained by the Little Owl Family. Purchase includes 77.5 Acres of surface estate, described as:

Tract number 984A-B consisting of 80 acres of W, SE of Sec 15 T147N, R90W, Sec 15, Fifth Principal Meridian, Mercer County, North (Surface only).

The area described contains a total of 80.0 acres, according to the Title Status Report, on file in the Bureau of Indian Affairs.

Reserving unto the United States that certain right-of-way for a road and all appurtenances thereto, constructed by the United States, through, over, or upon land herein described, and the right of the United States, its officers, agents, or employees, to maintain, operate, repair, or improve the same so long as needed or used for or by the United States.

To have and to hold the same, together with all the hereditaments and appurtenances thereunto belonging or in anywise appertaining forever.



EXCEPTING THEREFROM a reservation of all oil, gas and mineral rights.

- WHEREAS, The above-described land is owned, in trust, by the Little Owl Family; and
- WHEREAS, The Business Council has determined that the purchase price for the above described shall be \$600 per acre, for a total purchase price of \$46,500.00.
- NOW THEREFORE BE IT RESOLVED, that the Business Council hereby approves the purchase of the above-described 77.5 acres of surface estate owned by the Little Owl Family (life tenant and his remainder) for a total purchase price of \$46,500.00 plus the Tribes' portion of any and all costs associated with the closing of the transaction as identified in the attached purchase and sale agreement; and
- **BE IT FURTHER RESOLVED,** that the Business Council directs the Tribes' Chief Executive Officer to execute any and all necessary closing documents to consummate the purchase of the above-described land; and
- **BE IT FINALLY RESOLVED**, that the Chairman is hereby authorized to take such further actions as are necessary to carry out the terms and intent of this resolution.
