



**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled, "*Consent to a Right-of-Way across Tribal land Submitted by QEP Energy Company for Multi-Well Pad 16-22G.*"

- WHEREAS,** This Mandan Hidatsa and Arikara Nation (the "MHA Nation"), having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act, and having adopted a Constitution and By-laws under said Act, and
- WHEREAS,** Pursuant to Article III, Section 1 of its Constitution and By-Laws, the Tribal Business Council is the governing body of the MHA Nation; and
- WHEREAS,** Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and
- WHEREAS,** The Tribal Business Council has authority to engage in activities on behalf of and for the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS,** Article IX Sections 1 and 3 of the Constitution provides that the Tribal Business Council has the authority to manage and lease or otherwise deal with tribal lands and resources; and
- WHEREAS,** Leases and Rights-of-Way (ROWs) across tribal trust land require the consent of the Tribal Business Council pursuant to federal and tribal law; and
- WHEREAS,** Applications for ROW(s) on Tribal Land are subject to the requirements of tribal law, including Resolution No. 14-071-VJB (MHA Nation Application for ROW(s) and Use of ROW), Resolution No. 14-089-VJB (MHA Nation Pipeline Right-of-Way Terms and Conditions), and Resolution No. 15-045-LKH (Establishing a Procedure for the Approval of Leases, ROW(s), Setback Variances and Permissions to Survey on Tribal Land); and
- WHEREAS,** BIA ROW authorizing drilling up to three (3) wells from the 16-22G pad was granted on January 16, 2014 (ROW No. FBOG100816).
- WHEREAS,** The application for the ROW submitted by QEP, described herein, have been reviewed and recommended for approval in accordance with the MHA Nation's approved procedure for authorizing ROWs on tribal land; and



Resolution No. 16-141-LKH

WHEREAS, the ROW requested by QEP for **Pad 16-22G** is, as follows:

Allotment 770A (an undivided 1.0000000000 interest)

- To add one additional well to the existing pad located in the SE/4 of Section 22, Township 148 North, Range 92 West.

WHEREAS, Consideration was based off of \$25,000 for the initial well and well pad, \$5,000 for each additional well, and \$2,500 per acre of access road disturbance; and

WHEREAS, The MHA Nation Energy Division reviewed, processed and fully vetted QEP's request for ROWs for multi-well pad 16-22G and has determined that QEP has made a clear showing that granting the ROWs would not cause an adverse environmental effects upon the allotments described herein; and

WHEREAS, On June 13, 2016, at a duly held meeting of the Natural Resources Committee, the MHA Nation Energy Division recommended for approval QEP's ROW request for multi-well pad 16-22G, and the Natural Resources Committee approved QEP's ROW request for multi-well pad 16-22G.

NOW THEREFORE BE IT RESOLVED, the Tribal Business Council hereby approves the ROW, attached as Exhibit A, submitted by QEP for multi-well pad 16-22G; as follows:

Allotment 770A (an undivided 1.0000000000 interest)

- To add one additional well to the existing pad located in the SE/4 of Section 22, Township 148 North, Range 92 West.

BE IT FINALLY RESOLVED, that the Chairman is hereby to take such further actions as are necessary to carry out the terms and intent of this Resolution.




CERTIFICATION


