



**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES
OF THE FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled, “*Authorization and Request for Extension of Contract No. HHS-I-241-2017-00011, as a Term Contract.*”

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, Article VI, Section 3 of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council all necessary sovereign authority – legislative and judicial – for the purposes of exercising the jurisdiction granted by the People in Article I; and

WHEREAS, Article VI, Section 5(a) of the Constitution of the Three Affiliated Tribes states, in part, the Tribal Business Council shall have the powers to manage all economic affairs and enterprises of the MHA Nation; and

WHEREAS, Article VI, Section 5(c) of the Constitution of the Three Affiliated Tribes expressly authorizes and permits the Tribal Business Council to approve expenditures from Tribal funds for public purposes; and

WHEREAS, Article VI, Section 5(d), expressly authorizes and grants the specific authority for the Tribal Business Council to negotiate with Federal, State and Local governments on behalf of the Tribe; and

WHEREAS, Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes sets forth the powers of the Tribal Business Council to adopt resolutions regulating the procedure of Tribal agencies of the MHA Nation; and

WHEREAS, Article III of the Constitution of the Three Affiliated Tribes Provides that The Tribal Business Council is the governing body of the Tribes;

WHEREAS, Public Law 93-638, entitled the Indian Self-Determination and Education Assistance Act Authorizes to Indian Tribes assume governmental programs, functions, services or activities which are otherwise performed by the federal



Government by entering into a P.L. 93-638 Contract with the Secretary of the Department of Interior or the Secretary of the Department of Health and Human Services; and

WHEREAS, Pursuant to Resolution No. 07-189-VJB, the tribal Business Council requests to renew a P.L. 93-638 contract with the Indian Health Services to perform those program functions, services, and activities related directly and indirectly to the Fort Berthold Service Unit and the Tribal Field Clinics, and thereby entered into a three year contract with the Indian Health Service the term of which includes October 1, 2016 through September 30, 2019.

NOW THEREFORE BE IT RESOLVED, the Tribal Business Council hereby authorizes the renewal of Contract No. HHS-I-241-2017-00011 between the Three Affiliated Tribes and the Indian Health Service, whereby The Three affiliated Tribes and Indian Health Service will continue in its delivery of the program functions, services, and activities related directly and indirectly to the Fort Berthold Service Unit, including and not limited to the following:

1. Hospitals and Clinics
2. Diabetes
3. Dental
4. Alcohol
5. Mental Health
6. Public Health Nursing
7. Health Education
8. Facilities & Environmental Health
9. Purchased and Referred Care
10. Physician Services
