

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Approval of Donation for the Hope Manor 3 Sober Living Home."

- WHEREAS, The Mandan Hidatsa and Arikara Nation ("Nation" or "Tribes") having accepted the Indian Reorganization Act of June 18, 1934 ("IRA"), and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and
- WHEREAS, The Constitution of the Nation generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article III, Section 1 of the Constitution of the Nation provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Article VI, Section 5(1) of the Constitution of the Nation provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council; and
- WHEREAS, Article VI, Section 5(c) of the Constitution of the Nation specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purposes for the Tribes; and
- WHEREAS, The Three Affiliated Tribes have a deep interest in supporting and helping grow programs that combat chemical and alcohol addiction; and
- WHEREAS, There exists a great need for a men only sober living home in North Dakota which can serve the needs of tribal members and non-tribal members effectively; and
- WHEREAS, Hope Manor has been successful in its other endeavors to combat chemical and alcohol addiction of females through its construction and operation of female only sober living homes; and
- WHEREAS, Hope Manor is slated to open a male only sober living home and has requested a donation to support the said sober living home.
- NOW THEREFORE BE IT RESOLVED, the Business Council of the Three Affiliated Tribes hereby authorizes and approves donation in the amount of \$10,000, to Hope Manor; and
- **BE IT FURTHER RESOLVED**, the Tribal Chairman is hereby authorized to take such action as is necessary to carry out the terms and intent of this Resolution.
