



**RESOLUTION OF THE GOVERNING BODY
OF THE THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution Entitled, "Directive to the Office of Trust Fund Management to Make Available for Withdrawal by the Three Affiliated Tribes from the Three Affiliated Tribes Docket Accounts"

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and

WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and

WHEREAS, Article VI, Section 5(a) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council shall have the power to manage all economic affairs of the Three Affiliated Tribes; and

WHEREAS, Article VI, Section 5(c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purposes of the Tribes; and

WHEREAS, The Tribal Business Council adopted the FY 2016 General Fund Operating Budget for the Three Affiliated Tribes; and

WHEREAS the Tribal Business Council hereby requests the Office of Special Trustee to draw down the current balances of:

\$4,451.00 in account JA9006212
\$41,236.00 in account JA9009216
\$112,984.00 in account JA9028216

For a total draw down of \$158,671.00



NOW, THEREFORE BE IT RESOLVED, the Tribal Business Council hereby directs the Office of Special Trustee to prepare and process all documents to draw down the requested amount from accounts JA9006212, JA9009216, JA9028216; and

BE IT FURTHER RESOLVED, the Tribal Finance Department, within the Three Affiliated Tribes will submit a Standard Form 1034 to the Office of Special Trustee with the attachment of Resolution # 16-086 LKH.
