

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- A Resolution entitled, "Approval of Continuing Resolution For FY2017 General Fund Budget Expenditures Based Upon 75% of FY 2016 General Fund Budget."
- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5 (c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business to administer funds within the exclusive control of the Tribes and to make expenditures from available funds for the public purpose of the Tribes; and
- WHEREAS, The Tribal Business Council adopts a budget for every fiscal year; and
- WHEREAS, The Tribal Business Council is currently working on finalizing a FY2017 General Fund Budget; and
- WHEREAS, The Tribal Business Council fully believes that it is in the best interest of the Three Affiliated Tribes to develop a FY 2017 budget that is fiscally responsible and meets the needs of the Tribes and its members; and
- WHEREAS, The Tribal Business Council desires to continue to operate under the FY 2016 budget until such time as the Tribal Council can carefully consider and adopt an FY 2017 Budget.
- NOW THEREFORE BE IT RESOLVED, the Three Affiliated Tribes Tribal Business Council hereby approves expenditures at 75% of FY 2016 levels as reflected in the FY 2016 budget until such time the Tribal Business Council approves a budget for FY 2017.
