



**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled, “*Consent to Approval of a Right-of-Way Across Tribal Land for the Hidatsa North 13-24 Pad Project Submitted by WPX Energy Williston, LLC.*”

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and

WHEREAS, Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and

WHEREAS, Article IX Sections 1 and 3 of the Constitution provides that the Tribal Business Council has the authority to manage and lease or otherwise deal with tribal lands and resources; and

WHEREAS, Leases and Rights-of-Way (“ROWS”) across Tribal Trust land require the consent of the Tribal Business Council pursuant to federal and Tribal Law; and

WHEREAS, Applications for Rights-of-Way (“ROWS”) on Tribal Land are subject to the requirements of tribal law, including Resolution No. 13-109-VJB (Establishment of the Three Affiliated Tribes Standardized Minimum Rates for Oil and Gas Lease Bonus, Royalties and Road and Pipeline Easements), Resolution No. 14-071-VJB (MHA Nation Application for Rights-of-Way and Use of Right-of-Way), Resolution No. 14-089-VJB (MHA Nation Pipeline Right-of-Way Terms and Conditions), and Resolution No. 15-045-LKH (Establishing a Procedure for the Approval of Leases, Rights-of-Way, Setback Variances and Permissions to Survey on Tribal Land); and

WHEREAS, WPX Energy Williston, LLC (“WPX”) submitted a ROW application for the Hidatsa North 13-24 Pad Project for a well pad, eight (8) wellbores, an access road, utilities, fiber optics and above ground appurtenances, and pipeline & above ground appurtenances, temporary above-ground fresh water lines, connecting flowline & above ground appurtenances, across tribal tract T203A-A, with 100% tribal interest, in Section 11, Township 150 North, Range 93 West, in Mountrail County, North Dakota, as more particularly described in Appendix A.1.; and



WHEREAS, The ROW application, submitted by WPX for the Hidatsa North 13-24 Pad Project, described above, has been reviewed and recommended for approval by the MHA Natural Resources Department and the MHA Nation Energy Division in accordance with the MHA Nation's approved procedure for authorizing ROWs on Tribal Land; and

WHEREAS, The projected compensation to the MHA Nation for this ROW application is \$65,305.00; and

WHEREAS, On August 31st, 2016, at a duly held meeting of the Natural Resources Committee ("NRC"), the MHA Nation Energy Division recommended for approval of WPX's ROW application and consent request for the Hidatsa North 13-24 Pad Project, more fully described herein, and in the attached Appendix A.1., and the NRC approved WPX's application and forwarded it to the Tribal Business Council for final action.

NOW THEREFORE BE IT RESOLVED, Subject to WPX Energy Williston, LLC's agreement to the execution of the MHA Right-of-Way Application and Terms and Conditions, as listed therein, and payment of ROW fees, the Tribal Business Council hereby approves the following ROW application, more fully described herein, and in the attached Appendix A.1, and ROW consent, as follows:

- WPX Energy Williston, LLC – Hidatsa North 13-24 Pad Project, for a well pad, eight (8) well bores, an access road, utilities, fiber optics and above ground appurtenances, and pipeline & above ground appurtenances, temporary above-ground fresh water lines, connecting flowline & above ground appurtenances, across tribal tract T203A-A, with 100% tribal interest, in Section 11, Township 150 North, Range 93 West, in Mountrail County, North Dakota.

BE IT FINALLY RESOLVED, that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.
