



**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled, “*Thomas Breuer – Farm Lease on Tribal Allotment T104A-D*”

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and

WHEREAS, Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and

WHEREAS, Article IX Sections 1 and 3 of the Constitution provides that the Tribal Business Council has the authority to manage and lease or otherwise deal with tribal lands and resources; and

WHEREAS, Leases tribal trust land require the consent of the Tribal Business Council pursuant to federal and tribal law; and

WHEREAS, Application for Farm Lease for Thomas Breuer, 7060 13th Street NW, Garrison, N.D. 58540; and

WHEREAS, The applications for Farm Pasture Lease described herein have been reviewed and recommended for approval in accordance with the Three Affiliated Tribes’ approved procedure for authorizing leasing on Tribal Allotment Number T104A-D described herein.

NOW THEREFORE BE IT RESOLVED, the Business Council hereby consents to the following Farm Lease on Tribal Trust Allotment Number T104A-D, containing 32 tillable acres, more or less acres, at a rate of \$32.00 an acre. For a term of two (2) years, beginning the first day of January, 2017, to be completed and ended on the 31st day of December, 2018, subject to the conditions hereinafter set forth. Tribal Allotment Number 104A-D, in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 8, T. 148 N, R. 88 W, McLean County, 5th Principal Meridian of North Dakota, containing a 100% interest, as described in Appendix A.1.

BE IT FINALLY RESOLVED, that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.




CERTIFICATION



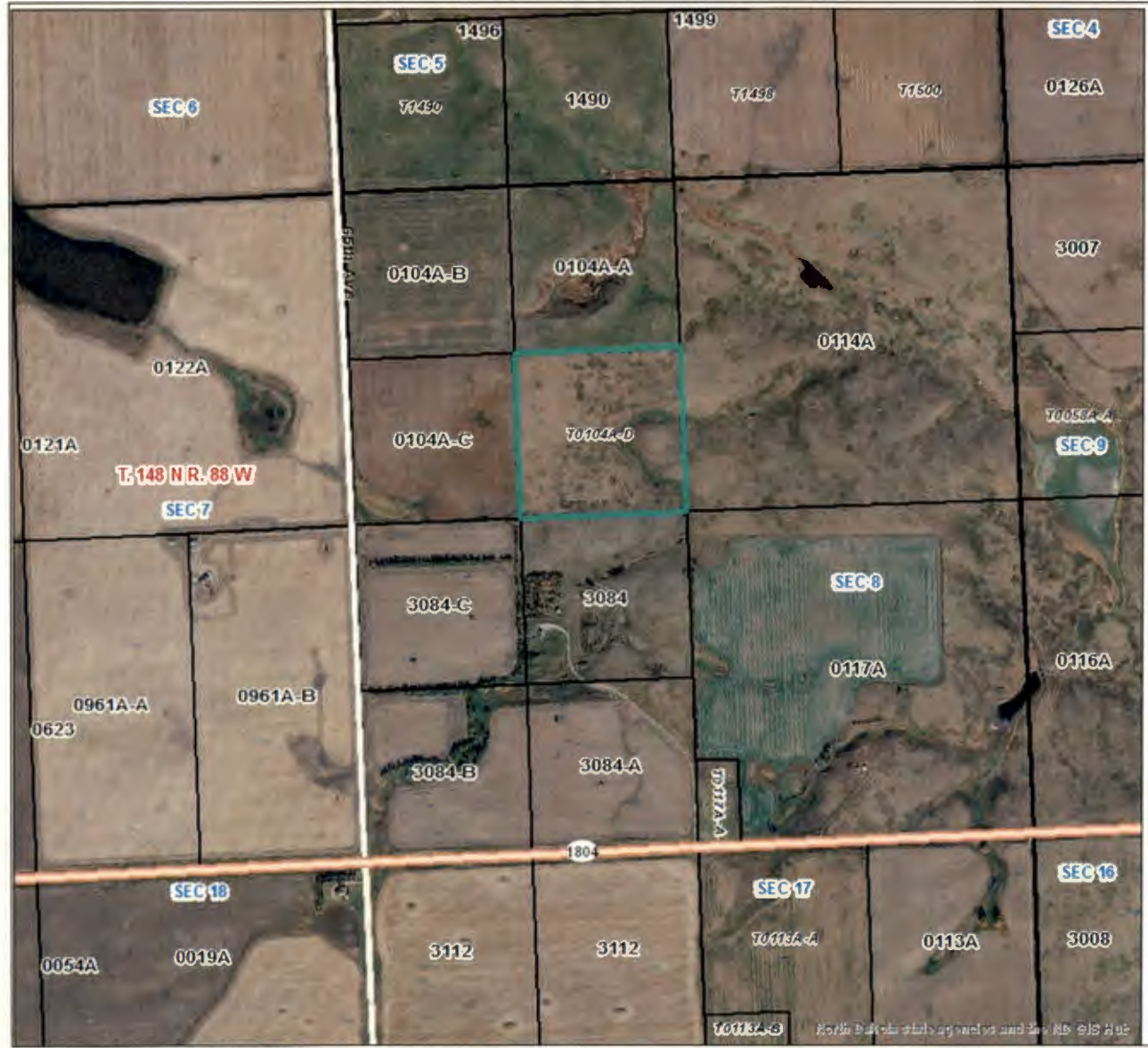
