



**RESOLUTION OF THE GOVERNING BODY  
OF THE THREE AFFILIATED TRIBES  
OF THE FORT BERTHOLD INDIAN RESERVATION**

**A Resolution Entitled, “Directive to the Three Affiliated Tribes to Make Available Funds for Withdrawal From the Northeast Segment of the Three Affiliated Tribes Account # \_\_\_\_\_ of all available funds from the 2016 Three Affiliated Tribes Northeast Segment budget for Boys and Girls Club Construction, an 8-plex Apartment Building, Wild Horse Addition, and the Elder’s Homes Construction.”**

**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and

**WHEREAS,** Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

**WHEREAS,** The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

**WHEREAS,** Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and

**WHEREAS,** Article VI, Section 5(c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purposes of the Tribes; and

**NOW, THEREFORE BE IT RESOLVED,** the Tribal Business Council hereby authorizes the drawdown of all available funds out of the 2016 Three Affiliated Tribes Northeast Segment account # \_\_\_\_\_ to pay for the Boys and Girls Club Construction, an 8-plex Apartment Building, Wild Horse Addition, and the Elder’s Homes Construction.


**CERTIFICATION**


