



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

**A Resolution entitled, "Amending Monthly Rental Fee Schedule for Solid Waste Container Rentals"**

**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 8, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and

**WHEREAS,** The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

**WHEREAS,** Article III, Section 1 of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

**WHEREAS,** Article VI, Section 5(c) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies; and

**WHEREAS,** The Three Affiliated Tribes Solid Waste needs to establish and update the rental fees for solid waste containers to support the cost of solid waste services.

**NOW THEREFORE BE IT RESOLVED,** that the Tribal Business Council of the Three Affiliated Tribes approves the following fee schedule for rentals of solid waste containers:

	Residential costs	Commercial
Trash cans	\$10.00 to \$15.00	\$ 20.00 to \$25.00
3 yarder	\$20.00 to \$25.00	\$ 50.00 to \$55.00
6 Yarder	\$30.00 to \$35.00	\$ 90.00 to \$95.00
20 yarder	\$ 300.00 Flat rate	\$300.00 + \$ 2.50 loaded mile
30 yarder	\$ 400.00 Flat rate	\$ 400.00 + \$ 2.50 loaded mile



## Resolution No. 17-104-FWF

20 and 30 yarders must be paid up front before delivery. One week is the time frame of use on 20 and 30 yarder rentals.

Elders 55 + in years will get free residential services and use of one roll off container (20 yarder or 30 yarder) per year (for clean up or renovation of home).

Elders 55+ business owners will be charged commercial rates for containers and services.

Elders 55+ that have caretakers (adult children) living with them. The adult children will take responsibility and will pay for services.

### **Inert Pit Tipping Fees**

Pick up box	\$10.00
Small Utility trailer	\$25.00
Large utility Trailer	\$45.00
Dump Truck or Side dump Trailer	\$120.00

### **Repossession of containers**

Trash containers will removed due to on unpaid bill (30 Days) and won't be returned till bill is paid in full and will have \$10 fee for return of container.

### **Landlords/Housing Authorities**

Landlords/Housing Authorities are responsible for paying their Tenants container service fee.

### **Fines**

A \$200 Dollar fine shall be imposed for dumping oil, metal, or appliances in the incorrect containers.


**CERTIFICATION**


