

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- A Resolution entitled, "Approval for transfer of responsibility on house and lot, located in Elbowoods Housing Development Phase 1, to the South Segment"
- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, The Constitution and By-laws of the Three Affiliated Tribes was adopted by membership of the Tribes on May 15th, 1936 pursuant to the Indian Reorganization Act of 1934 and duly approved by the Secretary of Interior; and
- **WHEREAS,** Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- **WHEREAS,** The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Three Affiliated Tribes owns the Home and Lot at 923 East Avenue, New Town, ND 58763 and located within the Elbowoods Housing Subdivision Phase 1; and
- **WHEREAS,** The responsibility and maintenance of the home and lot will be transferred over to the Twin Buttes Segment.
- NOW THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby approves the Tribal land and dwelling, known as 923 3rd Avenue East, Elbowoods Housing Subdivision, City of New Town, to the South Segment of the Three Affiliated Tribes. Under the terms and conditions as stated below and hereby authorizes the Chairman of the Tribal Business Council, to prepare all documents and do all things necessary to transfer the responsibility to the South Segment.
 - Maintain the House and Lot.
 - All Taxes and Assessment, related to the Lot.
 - Any additional items necessary



CERTIFICATION


