

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Todd Hall Land Sale to the Three Affiliated Tribes"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Three Affiliated Tribes' Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Natural Resources Committee of the Tribal Business Council approves the Purchase by the Tribe, the land described below; and
- WHEREAS, It has been determined that it is in the best interest of the Tribe to acquire land; and
- NOW THEREFORE BE IT RESOLVED, The Three Affiliated Tribes' Tribal business Council hereby approve the purchase of the surface lands described below from

Todd M. Hall, 301-U04133

For cash consideration of \$1,503,050.00, which is the negotiated value, utilizing funds from the FY2017 Land Purchase Judgement/Revenue Account, and hereby authorizes the Chairman of the Tribal Business Council, it's Secretary, the Superintendent of the Fort Berthold Agency, the Area Director, and Commissioner of the Indian Affairs to prepare all documents and do all things necessary to transfer title of the land to the United States of America, in trust for the Three Affiliated Tribes of the Fort Berthold Indian Reservation, to wit.

Lot 4, W ¹ / ₂ SW ¹ / ₄ , SW ¹ / ₄ NW ¹ / ₄ of Section 1; Lot 1, E ¹ / ₂ SE ¹ / ₄ , SE ¹ / ₄ NE ¹ / ₄ , of Section 2, Township 148 North, Range 92 West, 5 th Principal Meridian, Dunn County, North Dakota containing 300.61 acres, more or less, which he has a 100% interest.
