



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

**A Resolution entitled, “*Consent to Right-of-Way across Tribal land Submitted by Enerplus Resources for the Spiders Project (FEE).*”**

**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and

**WHEREAS,** Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and

**WHEREAS,** Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and

**WHEREAS,** Article IX Sections 1 and 3 of the Constitution provides that the Tribal Business Council has the authority to manage and lease or otherwise deal with tribal lands and resources; and

**WHEREAS,** Leases and Rights of Way (ROWS) across tribal trust land require the consent of the Tribal Business Council pursuant to federal and tribal law; and

**WHEREAS,** Applications for Rights of Way on Tribal Land are subject to the requirements of tribal law, including Resolution No. 14-071-VJB (MHA Nation Application for Rights of Way and Use of Right of Way), Resolution No. 14-089-VJB (MHA Nation Pipeline Right-of-Way Terms and Conditions), and Resolution No. 15-045-LKH (Establishing a Procedure for the Approval of Leases, Rights of Way, Setback Variances and Permissions to Survey on Tribal Land); and

**WHEREAS,** Enerplus Resources (USA) Corporation (“Enerplus”) submitted a ROW application for the Spiders Project for a well pad, ten (10) well bores, access road, utility, fiber optics, above ground appurtenances and temporary water line, across certain Tribally owned fee lands located in Section 32, Township 149 North, Range 92 West in Dunn County, North Dakota, as more particularly described in Appendix A.1; and

**WHEREAS,** The total acreage of the Spiders Project (Fee) is 18.721 acres encompassing 14.904 acres for the well pad, and 3.817 acres for the multi-use ROW purposes consisting of 1,343.70 feet; and

**WHEREAS,** The projected compensation to the MHA Nation for this ROW application is a onetime payment of \$82,832.36; and

**WHEREAS,** The ROW Application, submitted by Enerplus for the Spiders Project (Fee), described above, has been reviewed and recommended for approval by the MHA Natural Resources Department and the MHA Nation Energy Division in accordance with the MHA Nation's approved procedure for authorizing ROWs on Tribal Land; and

**WHEREAS,** On March 1, 2017, at a duly held meeting of the Natural Resources Committee ("NRC"), the MHA Nation Energy Division recommended for the approval of Enerplus's ROW consent request for the Spiders Project (Fee), more fully described herein, and in the attached Appendix A.1., and the NRC approved Enerplus's application and forwarded it to the Tribal Business Council for final action.

**NOW THEREFORE BE IT RESOLVED,** the Business Council hereby consents to the following ROW(s), subject to the respective Company's agreement to and execution of the Terms and Conditions and payment of ROW fees pursuant to Resolution No. 14-089-VJB:

- Enerplus Resources (USA) Corporation, Spiders Project, for a well pad, ten (10) well bores, access road, utility, fiber optics, above ground appurtenances and temporary water line, across certain Tribally owned fee lands located in Section 32, Township 149 North, Range 92 West in Dunn County, North Dakota.

**BE IT FINALLY RESOLVED,** that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.




