



**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled, “Consent to Approval of a Right-of-Way across Tribal land for the Elm Tree 16 South Loop Project Submitted by ONEOK Rockies Midstream, LLC.”

- WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and
- WHEREAS,** Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS,** Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and
- WHEREAS,** Article IX Sections 1 and 3 of the Constitution provides that the Tribal Business Council has the authority to manage and lease or otherwise deal with tribal lands and resources; and
- WHEREAS,** Leases and Rights-of-Way (“ROWs”) across Tribal Trust land require the consent of the Tribal Business Council pursuant to federal and Tribal Law; and
- WHEREAS,** Applications for Rights-of-Way (“ROWs”) on Tribal Land are subject to the requirements of tribal law, including Resolution No. 13-109-VJB (Establishment of the Three Affiliated Tribes Standardized Minimum Rates for Oil and Gas Lease Bonus, Royalties and Road and Pipeline Easements), Resolution No. 14-071-VJB (MHA Nation Application for Rights-of-Way and Use of Right-of-Way), Resolution No. 14-089-VJB (MHA Nation Pipeline Right-of-Way Terms and Conditions), and Resolution No. 15-045-LKH (Establishing a Procedure for the Approval of Leases, Rights-of-Way, Setback Variances and Permissions to Survey on Tribal Land); and
- WHEREAS,** ONEOK Rockies Midstream, LLC (“ONEOK”) submitted a ROW application for the Elm Tree 16 South Loop Project for a sixteen inch (16”) gas poly pipeline across certain tribal tracts on Allotment 587A, (0.0868421053 Tribal interest), in Section 10, Township 152 North, Range 94 West, in McKenzie County, North Dakota as more particularly described in Appendix A.1.; and



WHEREAS, The total acreage of the Elm Tree 16 South Loop Project is 0.07 acres consisting of 126.02 feet; and

WHEREAS, The projected compensation to the MHA Nation for this ROW application is a onetime payment of \$36.47; and

WHEREAS, The ROW Application, submitted by ONEOK for the Elm Tree 16 South Loop Project described above, has been reviewed and recommended for approval by the MHA Natural Resources Department and the MHA Nation Energy Division in accordance with the MHA Nation's approved procedure for authorizing ROWs on Tribal Land; and

WHEREAS, On March 1, 2017, at a duly held meeting of the Natural Resources Committee ("NRC"), the MHA Nation Energy Division recommended for the approval of ONEOK's ROW consent request for the Elm Tree 16 South Loop Project, more fully described herein, and in the attached Appendix A.1., and the NRC approved ONEOK's application and forwarded it to the Tribal Business Council for final action.

NOW THEREFORE BE IT RESOLVED, Subject to ONEOK Rockies Midstream, LLC agreement to the execution of the MHA Right-of-Way Application and Terms and Conditions, as listed therein, and payment of ROW fees, the Tribal Business Council hereby approves the following ROW application, attached as Appendix A.1, and ROW consent, as follows:

- ONEOK Rockies Midstream, LLC – the Elm Tree 16 South Loop Project for a sixteen inch (16") gas poly pipeline across certain tribal tracts on Allotment 587A, (0.0868421053 Tribal interest), in Section 10, Township 152 North, Range 94 West, in McKenzie County, North Dakota.

BE IT FINALLY RESOLVED, that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.




CERTIFICATION


