

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- A Resolution entitled, "Authorization for a one-time Disbursement of Funds from Tribal Oil & Gas Royalty Revenues to All Enrolled Members of the Three Affiliated Tribes"
- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Article VI, Section 5 (c) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to administer any funds or property within the exclusive control of Tribes and to make expenditures from available tribal funds for public purposes of the Tribes; and
- WHEREAS, The Three Affiliated Tribes have benefitted greatly from the oil & gas development and activity on the Fort Berthold Indian Reservation; and
- **WHEREAS,** The Tribal Business Council wishes to provide the enrolled membership with a disbursement of the Tribes' oil & gas royalty revenues.
- **THEREFORE BE IT RESOLVED,** The Tribal Business Council of the Three Affiliated Tribes hereby formally approves a one-time disbursement of funds from oil & gas royalty revenues to all enrolled members of the Three Affiliated Tribes; and
- **BE IT FURTHER RESOLVED**, Each enrolled member of the Three Affiliated Tribes as of March 9, 2017 and regardless of age shall receive a one-time disbursement in the amount of one thousand dollars (\$1,000.00); and
- **BE IT FURTHER RESOLVED,** Enrolled members under the age of 14 as of July 1, 2017 will be required to have a legal guardian fill out an "instruction for disbursement form" and return to finance. Forms will be available at Tribal Finance, segment offices and the MHA website.



- **BE IT FURTHER RESOLVED,** Enrolled members under the age of 14 as of July 1, 2017 that do not have a completed "instruction for disbursement form" returned to Tribal Finance by July 1, 2017 will have disbursement held in a Trust account until the age of 18.
- **BE IT FURTHER RESOLVED,** Enrolled members under the age of 14 as of July 1, 2017 in the custody of The Three Affiliated Tribes shall have their disbursement held in a Trust account until the age of 18.
- **BE IT FURTHER RESOLVED,** The authorized one-time disbursement shall be taken exclusively from existing oil & gas royalty revenues of the Three Affiliated Tribes; and
- **BE IT FURTHER RESOLVED,** No funds for the one-time disbursement approved by this Resolution shall be taken from any funds on deposit for the benefit of the Nuxbaaga Iidaa Uuh Waa Zaah, Sahnis waaplsis, Aki numuk aki tawatesh sha geddish, The People's Fund; and
- **BE IT FURTHER RESOLVED,** The Chief Financial Officer of the Three Affiliated Tribes shall work to identify the appropriate accounts and to make ready for issuance of the one-time disbursement in accordance with this Resolution; and
- **BE IT FINALLY RESOLVED,** the Disbursement authorized by this Resolution shall be sent via U.S. Mail to the last known address of the individual no later than April 21, 2017.
