

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- A Resolution entitled, "Consent to Approval of a Right-of-Way across Tribal land for the Little Missouri River Unit West Project Submitted by Missouri River Resources."
- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and
- WHEREAS, Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and
- WHEREAS, Article IX Sections 1 and 3 of the Constitution provides that the Tribal Business Council has the authority to manage and lease or otherwise deal with tribal lands and resources; and
- WHEREAS, Leases and Rights-of-Way ("ROWs") across Tribal Trust land require the consent of the Tribal Business Council pursuant to federal and Tribal Law; and
- WHEREAS, Applications for Rights-of-Way ("ROWs") on Tribal Land are subject to the requirements of tribal law, including Resolution No. 17-117-FWF, Resolution No. 14-071-VJB (MHA Nation Application for Rights-of-Way and Use of Right-of-Way), Resolution No. 14-089-VJB (MHA Nation Pipeline Right-of-Way Terms and Conditions), and Resolution No. 15-045-LKH (Establishing a Procedure for the Approval of Leases, Rights-of-Way, Setback Variances and Permissions to Survey on Tribal Land); and
- WHEREAS, Missouri River Resources submitted a ROW application for the Little Missouri River Unit West for a well pad, CTB pad, pipeline, access road, utilities, fiber optics and above ground appurtenances, across certain tribal tracts in:

Allotment T1950, with 100% tribal interest, in Section 20, Township 147 North, Range 93 West, in Dunn County, North Dakota as more particularly described in Appendix A.1.; and



Allotment 1104A, with 10% tribal interest, in Section 8, 9, 16, and 17, Township 147 North, Range 93 West, in Dunn County, North Dakota as more particularly described in Appendix A.1.; and

Allotment 2134, 88.33% with tribal interest, in Section 16 and 17, Township 147 North, Range 93 West, in Dunn County, North Dakota as more particularly described in Appendix A.1.; and

Allotment T1827, with 100% tribal interest, in Section 16 and 17, Township 147 North, Range 93 West, in Dunn County, North Dakota as more particularly described in Appendix A.1.; and

Allotment 1738, with 79.52% tribal interest, in Section 20, Township 147 North, Range 93 West, in Dunn County, North Dakota as more particularly described in Appendix A.1.; and

- WHEREAS, The ROW application, submitted by Missouri River Resources for the Little Missouri River Unit West Project, described above, has been reviewed and recommended for approval by the MHA Natural Resources Department and the MHA Nation Energy Division in accordance with the MHA Nation's approved procedure for authorizing ROWs on Tribal Land; and
- WHEREAS, The projected compensation to the MHA Nation for this ROW application is \$169,224.27; and
- WHEREAS, On June 1, 2017 at a duly held meeting of the Natural Resources Committee ("NRC"), the MHA Nation Energy Division recommended for approval of Missouri River Resources ROW application and consent request for the Little Missouri River Unit West Project more fully described herein, and in the attached Appendix A.1., and the NRC approved Missouri River Resources' application and forwarded it to the Tribal Business Council for final action.
- NOW THEREFORE BE IT RESOLVED, Subject to Missouri River Resources agreement to the execution of the MHA Right-of-Way Application and Terms and Conditions, as listed therein, and payment of ROW fees, the Tribal Business Council hereby approves the following ROW application, attached as Appendix A.1, and ROW consent, as follows:
 - Missouri River Resources the Little Missouri River Unit West Project, for well
 pad, CTB pad, access road, pipeline, utilities, fiber optics and above ground
 appurtenances across certain tribal tracts in:

Allotment T1950, with 100% tribal interest, in Section 20, Township 147 North, Range 93 West, in Dunn County, North Dakota.



Allotment 1104A, with 10% tribal interest, in Section 8, 9, 16, and 17, Township 147 North, Range 93 West, in Dunn County, North Dakota.

Allotment 2134, with 88.33% tribal interest, in Section 16 and 17, Township 147 North, Range 93 West, in Dunn County, North Dakota.

Allotment T1827, with 100% tribal interest, in Section 16 and 17, Township 147 North, Range 93 West, in Dunn County, North Dakota.

Allotment 1738, with 79.52% tribal interest, in Section 20, Township 147 North, Range 93 West, in Dunn County, North Dakota.

BE IT FINALLY RESOLVED, that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.

CERTIFICATION
