



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

***A Resolution entitled, "Authorization for the MHA Energy Division and the MHA Planning & Grants Department to Submit a Grant Proposal to the U.S. Department of the Interior, Office of the Assistant Secretary-Indian Affairs, through the Office of Indian Energy and Economic Development, the Division of Energy and Mineral Development in response to Solicitation for Proposals for BIA-000-0007-TEDC Grant Program to fund the Optimizing Tribal Data through Technology Project."***

**WHEREAS,** This Mandan Hidatsa and Arikara Nation (the "MHA Nation"), having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act, and having adopted a Constitution and By-laws under said Act, is a Federally recognized Indian Tribe exercising inherent sovereignty and jurisdiction over the Fort Berthold Indian Reservation ("FBIR"); and

**WHEREAS,** Pursuant to Article III, Section 1 of its Constitution and By-Laws, the Tribal Business Council is the governing body of the MHA Nation empowered with governmental authority to take certain action, including adopting means and resolution on behalf of the MHA Nation; and

**WHEREAS,** Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and

**WHEREAS,** Pursuant to Article VI, Section 5(d) of said Constitution, the Tribal Business Council has the power to negotiate with federal, state and local governments on behalf of the MHA Nation and to advise and consult with representatives of the United States Department of the Interior ("DOI") on all activities that may affect the MHA Nation and the FBIR; and

**WHEREAS,** the MHA Nation has duly elected Tribal Chairman, who is authorized on behalf of the MHA Nation to enter into a contract through the Bureau of Indian Affairs ("BIA"); and

**WHEREAS,** The MHA Nation, through its Energy Division in conjunction with its Planning & Grants Department, seeks to submit a Grant Proposal to the U.S. Department of the Interior, Office of the Assistant Secretary-Indian Affairs, through the Office of Indian Energy and Economic Development, the Division of Energy and Mineral Development in response to BIA-000-0007-TEDC, Solicitation for Proposals for



the Grant Program to Build Tribal Energy Development Capacity (TEDC), to fund the MHA Nation Project to “Optimize Data Through Technology”; and

**WHEREAS,** The FBIR is located in the heart of the massive Bakken oil formation, and the MHA Nation has been engaged in oil and gas development for the past decade making it one of the top oil producing Indian tribes in the country; and

**WHEREAS,** The Tribal Business Council deems it necessary to assess the value and feasibility of developing the MHA Nation’s vast renewable energy resources for the long term sustainability of its governance and for the benefit of its tribal members; and

**WHEREAS,** The MHA Nation has a number of other natural resources and understands the importance of analyzing such resources in order to value and grade the feasibility of developing each resource, especially in light of the finite and nonrenewable nature of oil and gas production and extraction; and

**WHEREAS,** Managing the flow of MHA Nation’s vast mineral resources and information is never easy at any level of oil production, as up-to-date, reliable information and data is needed to monitor leases, communitization agreements, rights-of-ways, oil and gas sales, and environmental incidents, and often this information is lost between paper documents, complicated software programs, and spreadsheets or voids where such data just doesn’t exist; the result is inaccurate and inaccessible information that causes a myriad of problems; and

**WHEREAS,** The MHA Nation Energy Division plans to submit a DEMD TEDC proposal on behalf of the MHA Nation to develop a cloud based data system to allow the MHA Nation to manage and develop its vast natural resources; and

**WHEREAS,** The designated MHA Nation tribal representative to oversee the project work, make authorized decisions during the course of the MHA Nation Tribal Utility Feasibility Study project proposal, described herein, and be responsible for submitting quarterly and final progress reports, will be [name/title], who will referred to as the “Tribal Project Manager”; and

**WHEREAS,** The MHA Nation is willing to consider developing any potential energy and mineral resource discovered; and

**WHEREAS,** The MHA Nation will consider public release of non-proprietary data or reports obtained by the EMDP project, described herein.

**NOW, THEREFORE BE IT RESOLVED,** that the Tribal Business Council hereby authorizes the MHA Nation Energy Division in conjunction with MHA Nation Planning &



Grants Department, to submit a Grant Proposal to the U.S. Department of the Interior, Office of the Assistant Secretary-Indian Affairs, through the Office of Indian Energy and Economic Development, the Division of Energy and Mineral Development in response to BIA-000-0007-TEDC, Solicitation for Proposals for the Grant Program to Build Tribal Energy Development Capacity (TEDC), to fund the MHA Nation Tribal Utility Feasibility Study.

**BE IT FURTHER RESOLVED**, that the Tribal Chairman is hereby authorized to execute all necessary documents and take all action to fulfill the mandates of this Resolution.


**CERTIFICATION**


