

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Authorization for the MHA Energy Division and the MHA Planning & Grants Department to Submit a 2017 Energy and Mineral Development Project (EMDP) grant proposal to the U.S. Department of the Interior, Office of the Assistant Secretary-Indian Affairs, Division of Energy and Mineral Development (DEMD) to fund Using Results from the Preliminary Analysis, Optimize Field Development Model Project."

- WHEREAS, This Mandan Hidatsa and Arikara Nation (the "MHA Nation"), having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act, and having adopted a Constitution and By-laws under said Act, is a Federally recognized Indian Tribe exercising inherent sovereignty and jurisdiction over the Fort Berthold Indian Reservation ("FBIR"); and
- WHEREAS, Pursuant to Article III, Section 1 of its Constitution and By-Laws, the Tribal Business Council is the governing body of the MHA Nation empowered with governmental authority to take certain action, including adopting means and resolution on behalf of the MHA Nation; and
- WHEREAS, Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and
- WHEREAS, Pursuant to Article VI, Section 5(d) of said Constitution, the Tribal Business Council has the power to negotiate with federal, state and local governments on behalf of the MHA Nation and to advise and consult with representatives of the United States Department of the Interior ("DOI") on all activities that may affect the MHA Nation and the FBIR; and
- WHEREAS, the MHA Nation has duly elected Tribal Chairman, who is authorized to enter into a contract though the Bureau of Indian Affairs ("BIA") on behalf of MHA Nation; and
- WHEREAS, The MHA Nation, through its Energy Division in conjunction with its Planning & Grants Department, seeks to submit a 2017 Energy and Mineral Development Project (EMDP) grant proposal to the U.S. Department of the Interior, Office of Assistant Secretary-Indian Affairs, Division of Energy and Mineral Development (DEMD) to fund Using Results from the Preliminary Analysis, Optimize Field Development Model project; and



- WHEREAS, The FBIR is located in the heart of the massive Bakken oil formation, and the MHA Nation has been engaged in oil and gas development for the past decade making it one of the top oil producing Indian tribes in the country; and
- WHEREAS, MHA Nation's oil holdings are considerable, comprising 2.1% of the daily production of the United States is generated on the FBIR with the Tribal Trust acreage making up approximately 18% of that amount; and
- WHEREAS, The Tribal Business Council deems it necessary to assess the value and feasibility of developing the MHA Nation's vast renewable energy resources for the long term sustainability of its governance and for the benefit of its tribal members; and
- WHEREAS, The MHA Nation Energy Division plans to submit a proposal to the DEMD on behalf of the MHA Nation to generate a FIELD DEVELOPMENT MODEL (FDM) that will provide the Tribal Business Council a financial understanding of royalty revenues over the next 10-20 years, which is extremely important given that projections for a Indian mineral owners on the FBIR have unique complicating factors; and
- WHEREAS, To complement the FDM proposal, the MHA Nation Energy Division plans to also submit a project proposal Using Results from the Preliminary Analysis, to Optimize the FDM, with the following objectives:
  - To finish developing the FDM, a long term solution, with updates, that estimates trust net royalty revenue forecast in the 10–20 year period for the Tribal Business Council;
  - Underlying the FDM is an updateable database with verified reservoir characteristics;
  - Will also include "What If?" analysis tools which will allow for detailed and sophisticated analysis of complex oil scenarios which will surely develop; and
- WHEREAS, The designated MHA Nation tribal representative to oversee the project work, make authorized decisions during the course of the FDM project proposal, described herein, and be responsible for submitting quarterly and final progress reports, will be [name/title], who will referred to as the "Tribal Project Manager"; and
- WHEREAS, The MHA Nation is willing to consider developing any potential energy and mineral resource discovered; and
- WHEREAS, The MHA Nation will consider public release of non-proprietary data or reports obtained by the EMDP project, described herein.



NOW, THEREFORE BE IT RESOLVED, that the Tribal Business Council hereby authorizes the MHA Nation Energy Division in conjunction with MHA Nation Planning & Grants Department, to submit a 2017 Energy and Mineral Development Project (EMDP) grant proposal to the U.S. Department of the Interior, Office of Assistant Secretary-Indian Affairs, Division of Energy and Mineral Development (DEMD) to fund a proposal Using Results from the Preliminary Analysis, to Optimize the FDM project.

**BE IT FURTHER RESOLVED,** that the Tribal Chairman is hereby authorized to execute all necessary documents and take all action to fulfill the mandates of this Resolution.
