



**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution Entitled, “*Consent to Approval of a Right-of-Way Across Tribal Land for the Loop 17- Segment 2 Moccasin Substation Project Submitted by McKenzie Electric Cooperative.*”

- WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and
- WHEREAS,** Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS,** Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and
- WHEREAS,** Article IX Sections 1 and 3 of the Constitution provides that the Tribal Business Council has the authority to manage and lease or otherwise deal with tribal lands and resources; and
- WHEREAS,** Leases and Rights-of-Way (“ROWS”) across Tribal Trust land require the consent of the Tribal Business Council pursuant to federal and Tribal Law; and
- WHEREAS,** Applications for Rights-of-Way (“ROWS”) on Tribal Land are subject to the requirements of tribal law, including Resolution No. 13-109-VJB (Establishment of the Three Affiliated Tribes Standardized Minimum Rates for Oil and Gas Lease Bonus, Royalties and Road and Pipeline Easements), Resolution No. 14-071-VJB (MHA Nation Application for Rights-of-Way and Use of Right-of-Way), Resolution No. 14-089-VJB (MHA Nation Pipeline Right-of-Way Terms and Conditions), and Resolution No. 15-045-LKH (Establishing a Procedure for the Approval of Leases, Rights-of-Way, Setback Variances and Permissions to Survey on Tribal Land); and
- WHEREAS,** The MHA Nation and McKenzie Electric Cooperative, Inc. (“McKenzie Electric”) executed a “Public Utility Right-of-Way Consent Terms and Conditions” agreement effective January 1, 2016, governing McKenzie Electric’s construction, operation, maintenance, modification, rebuilding, or removal of electrical and distribution lines and associated facilities on the Fort Berthold Indian Reservation, and said agreement contains specified compensation terms; and



WHEREAS, McKenzie Electric submitted a ROW application for the Loop 17- Segment 2 Moccasin Substation Project for an electrical Right-Of-Way, across 64.751 acres on certain Tribal tracts in Allotments: 1007A (0.6487603306 Tribal interest), 1044A (0.0857767490 Tribal interest), 1104A (0.1000000000 Tribal interest), 1105A-C (0.1000000000 Tribal interest), 1700 (0.0277777778 Tribal interest), 2134 (0.8833333333 Tribal interest), T1029A-A (100% Tribal interest), T1029A-B (100% Tribal interest), T2028 (100% Tribal interest), T2189 (100% Tribal interest) and T5298 (100% Tribal interest) in Sections 2, 3, 8, 9, 10, 11, 14, 15, 16, 17, 34, 35, Townships 147 North and 148 North, Range 93 West, in Dunn County, North Dakota as more particularly described in Appendix A.1.; and

WHEREAS, The ROW application, submitted by McKenzie Electric for the Loop 17- Segment 2 Moccasin Substation Project, described above, has been reviewed and recommended for approval by the MHA Natural Resources Department and the MHA Nation Energy Division in accordance with the MHA Nation's approved procedure for authorizing ROWs on Tribal Land; and

WHEREAS, In accordance with MHA Nation Public Utility Right-Of-Way Consent Terms and Conditions with McKenzie Electric Cooperative, Inc., the projected compensation to the MHA Nation for this ROW application is \$53,889.47, which consists of the Nation's proportionate ownership share, as follows:

- \$15,693.42 for Allotment 1007A (0.6487603306 Tribal interest),
- \$10,750.00 for Allotment 1044A (0.0857767490 Tribal interest),
- \$7,250.00 for Allotment 1104A (0.1000000000 Tribal interest),
- \$4,250.00 for Allotment 1105A-C (0.1000000000 Tribal interest),
- \$5,250.00 for Allotment 1700 (0.0277777778 Tribal interest),
- \$750.00 for Allotment 2134 (0.8833333333 Tribal interest),
- \$5,750.00 for Allotment T1029A-A (100% Tribal interest),
- \$1,250.00 for Allotment T1029A-B (100% Tribal interest),
- \$7,872.10 for Allotment T2028 (100% Tribal interest),
- \$8,707.34 for Allotment T2189 (100% Tribal interest),
- \$17,250.00 for Allotment T5298 (100% Tribal interest); and

WHEREAS, On October 10, 2017 at a duly held meeting of the Natural Resources Committee ("NRC"), the MHA Nation Energy Division recommended approval of McKenzie Electric's ROW application and consent request for the Loop 17 – Segment 2 Moccasin Substation Project, more fully described herein, and in the attached Appendix A.1., and the NRC approved McKenzie Electric's application and forwarded it to the Tribal Business Council for final action.

NOW THEREFORE BE IT RESOLVED, Subject to McKenzie Electric Cooperative's agreement to the execution of the MHA Right-of-Way Application and Terms and



Conditions, as listed therein, and payment of ROW fees, the Tribal Business Council hereby approves the following ROW application, attached as Appendix A.1, and ROW consent, as follows:

- McKenzie Electrical Cooperative – the Loop 17- Segment 2 Moccasin Substation Project for an electrical Right-Of-Way, across 64.751 acres on certain Tribal tracts in Allotments: 1007A (0.6487603306 Tribal interest), 1044A (0.0857767490 Tribal interest), 1104A (0.1000000000 Tribal interest), 1105A-C (0.1000000000 Tribal interest), 1700 (0.0277777778 Tribal interest), 2134 (0.8833333333 Tribal interest), T1029A-A (100% Tribal interest), T1029A-B (100% Tribal interest), T2028 (100% Tribal interest), T2189 (100% Tribal interest) and T5298 (100% Tribal interest) in Sections 2, 3, 8, 9, 10, 11, 14, 15, 16, 17, 34, 35, Townships 147 North and 148 North, Range 93 West, in Dunn County, North Dakota.

BE IT FINALLY RESOLVED, that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.


CERTIFICATION


