

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Approving of Architect/Engineer Contract with Nelson Tremain Partnership for Satellite Outreach Facility in Bismarck, North Dakota"

- WHEREAS, The Mandan Hidatsa and Arikara Nation ("Nation" or "MHA Nation") having accepted the Indian Reorganization Act of June 18, 1934 ("IRA"), and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and
- WHEREAS, The Constitution of the Nation generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article III, Section 1 of the Constitution of the Nation provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Article VI, Section 5(c) of the Constitution of the MHA Nation specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Nation and to make expenditures from available Tribal funds for public purposes for the Nation; and
- WHEREAS, The Tribal Business Council has determined it beneficial to develop a satellite outreach facility ("Project") in Bismarck, North Dakota given the population of Tribal members living in Bismarck, North Dakota for the use and enjoyment by the members and to promote the health and economic development of the Tribe and its members; and
- WHEREAS, The Tribal Business Council engaged the Nelson Tremain Partnership ("Nelson Partnership") for architecture and design services for the Pre-Design phase of the Project; and
- WHEREAS, The Nelson Partnership has presented a Standard Form of Agreement between Owner and Architect outlining the scope of work to be performed by Nelson Partnership for the Project and the proposed cost for their services, hereby attached as Exhibit A of this Resolution; and
- WHEREAS, The Nelson Partnership propose a fixed fee of \$ 421,075.00 plus reimbursable expenses for their services for the Project and to be paid in accordance to their proposed Payment Schedule, hereby attached as Exhibit B of this Resolution; and
- WHEREAS, The Nelson Partnership's reimbursable expenses include expenses incurred by Nelson Partnership directly related to the Project, as follows:

- 1. Transportation and authorized out-of-town travel and subsistence;
- 2. Long distance services, dedicated data and communication services, teleconference, Project Web sites, and extranets;
- 3. Fees paid for securing approval of authorities having jurisdiction over this Project;
- 4. Printing, reproduction, plots, standard form documents;
- 5. Postage, handling, and delivery;
- 6. Expense of overtime work requiring higher than regular rates, if authorized in advance by the Owner;
- 7. Rendering, models, mock-up, professional photography, and presentation materials requested by the Owner;
- 8. Architect's Consultant's expense of professional liability insurance dedicated exclusively to this Project, or the expense of additional insurance coverage or limits if the Owner requests such insurance in excess of that normally carried by the Architect's consultants;
- 9. All taxes levied on professional services and on reimbursable expenses;
- 10. Site office expenses; and
- 11. Other similar Project-related expenditures.
- WHEREAS, The Tribe will be responsible for certain administrative costs in preparation for construction and as outlined in the Scope Responsibility Matrix, hereby attached as Exhibit C of this Resolution; and
- WHEREAS, The Tribal Business Council has reviewed the Standard Form of Agreement between Owner and Contractor and finds it acceptable;
- WHEREAS, The Tribal Business Council has reviewed the Scope Responsibility Matrix and finds it acceptable;
- NOW THEREFORE BE IT RESOLVED, The Tribal Business Council of the Three Affiliated Tribes authorizes the construction of the Satellite Outreach Facility in Bismarck, North Dakota for the use and enjoyment by the citizens and to promote the health and economic development of the Tribe and its members.
- BE IT FURTHER RESOLVED, the Tribal Business Council of the Three Affiliated Tribes hereby approves the Standard Form of Agreement between Owner and Contractor with Nelson Partnership for all architecture, engineer, and design work for the Project in the amount of \$421,075.00 plus reimbursable expenses in accordance with the Standard Form of Agreement between Owner and Contractor, substantially in the form attached hereto and incorporated herein by reference.
- **BE IT FURTHER RESOLVED,** the Tribal Business Council of the Three Affiliated Tribes hereby approves all necessary administrative expenses to be incurred in preparation for construction.
- **BE IT FINALLY RESOLVED**, the Tribal Chairman is hereby authorized execute the Standard Form of Agreement between Owner and Contractor with Nelson



Partnership, and to take such action as is necessary to carry out the terms and intent of this Resolution.
