

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled: "Approving and Supporting MHA DOT to Distribute its Own License Plates, Registrations, and Tags."

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act, and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The governing body of the Mandan, Hidatsa and Arikara Nation has the inherent authority to regulate traffic activities within the reservation and has established certain regulations on members and non-members within the exterior boundaries of the Fort Berthold Reservation regarding the commercial operation of Trucks, Tractor Trailers, and Heavy Equipment; and
- WHEREAS, It is in the Tribes' interest to foster, encourage and promote the health, welfare and safety of the people, the lands, resources and roads in such a manner as will minimize risk and properly manage truck, trailer, and heavy equipment traffic through the City of New Town; and
- WHEREAS, The governing body of the Mandan, Hidatsa, and Arikara Nation has an obligation on behalf of its constituents and members to provide safety and order to traffic in and around the Fort Berthold Indian Reservation.
- NOW THEREFORE BE IT RESOLVED, that the Tribal Council hereby acknowledges and supports the efforts of the MHA DOT Director and Licensing Administrator to proceed with the sale and distribution of vehicle licenses, plates, and tags on the Fort Berthold Indian Reservation; and
- NOW THEREFORE BE IT FURTHER RESOLVED, The Tribal Business Council authorizes its MHA Department of Transportation Administration to sell and distribute license plates, registration, tags and renewal of tags to vehicles, trucks, trailers, heavy equipment, mobile homes, semitrailers, motorcycles, and school



buses operating on the Fort Berthold Indian Reservation in an effort to regulate, monitor, and assert sovereignty and autonomy within the exterior boundaries of the Fort Berthold Indian Reservation.

CERTIFICATION
