



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

**A Resolution entitled, “Mandaree Enterprises, LLC Owner Exclusion for MEC FS JV  
Contract”**

**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and

**WHEREAS,** Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and

**WHEREAS,** Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and

**WHEREAS,** Mandaree Enterprises, through its President Clarence O'Berry, has represented to the Tribal Business Council that it needs a Resolution of exclusion affirming that the Three Affiliated Tribes, its officers and directors, as such, will not have access to classified information in the custody of MEC FS JV, a subsidiary corporation, and further that MEC FS JV has been delegated full authority to act completely independent of The Three Affiliated Tribes in all matters that involve or relate to MEC FS JV's responsibility to safeguard classified information.

**NOW THEREFORE BE IT RESOLVED,** That the Three Affiliated Tribes, its officers and directors, as such, will not require and will not have access to classified information in the custody of MEC FS JV, a subsidiary corporation, and further that MEC FS JV has been delegated full authority to act completely independent of The Three Affiliated Tribes in all matters that involve or relate to MEC FS JV's responsibility to safeguard classified information; and

**BE IT FINALLY RESOLVED,** That this action is taken for the purpose of exempting The Three Affiliated Tribes from the necessity of being processed for a Facility Security Clearance in conformity with the Department of Defense's "National Industrial Security Program Operating Manual."
