

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled, "Approval of Partition between Allotment Number 301-1087."

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5 (i) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to make arrangements and leases of Tribal Lands, and otherwise to manage Tribal Lands; and
- WHEREAS, Article VI, Section 5 (j) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to protect and preserve the property, wildlife, and natural resources of the Tribes; to regulate hunting and fishing on all lands within the jurisdiction of the Tribes, and to cultivate and preserve native arts, crafts, culture, ceremonies and traditions; and
- WHEREAS, Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal Agencies and Tribal officials of the Reservation; and
- WHEREAS, Three Affiliated Tribes, 301-T1087, requests for partitions an undivided interest in Allotment Number T301-1087, Section 34, T. 147.00N., R. 091.00W. Dunn County, 5th Principal Meridian of North Dakota, containing an undivided 98%; containing 30 acres, more or less; and
- WHEREAS, Jeb P. Fredericks, 301-U004069, retains their undivided interest in Allotment Number T301-1087, Section 34, T. 147.00N., R. 091.00W. Dunn County, 5th Principal Meridian of North Dakota, containing an undivided 0.53%; containing 0.1 acres, more or less; and
- WHEREAS, Kenneth Fredericks, Jr., 301-U003295, retains their undivided interest in Allotment Number T301-1087, Section 34, T. 147.00N., R. 091.00W. Dunn County, 5th Principal Meridian of North Dakota, containing an undivided 0.53%; containing 0.1 acres, more or less; and



- WHEREAS, Melanie A. Fredericks, 301-U006811, retains their undivided interest in Allotment Number T301-1087, Section 34, T. 147.00N., R. 091.00W. Dunn County, 5th Principal Meridian of North Dakota, containing an undivided 0.53%; containing 0.1 acres, more or less; and
- WHEREAS, Sharon Keene, 301-U0022915, retains their undivided interest in Allotment Number T301-1087, Section 34, T. 147.00N., R. 091.00W. Dunn County, 5th Principal Meridian of North Dakota, containing an undivided 2.77%; containing 0.8 acres, more or less; and
- WHEREAS, Brenda Fredericks, 301-X039227, retains their undivided interest in Allotment Number T301-1087, Section 34, T. 147.00N., R. 091.00W. Dunn County, 5th Principal Meridian of North Dakota, containing an undivided 0.53%; containing 0.1 acres, more or less.
- NOW THEREFORE BE IT RESOLVED, The Tribal Business Council hereby approves the following partitionment of Allotment Number 301-1087, surface only, as proposed by the Three Affiliated Tribes as the land owner; and
- **BE IT FINALLY RESOLVED,** that the Chairman is hereby authorized to execute such documents and take further actions as are necessary to carry out the terms and intent of this Resolution.
