

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Authorizing an Agreement with XTIRI for Centralized Technology and Data Based Services"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and
- WHEREAS, Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and
- WHEREAS, There is a need for a cost effective central data system which protects confidentiality and contains, monitors and analyzes all the data compiled on behalf of the MHA Nation including but not limited to natural resources, energy development and production, oil & gas production management and field operations, theft prevention, oilfield waste management, water settlement rights, tribal housing and facility management, TERO, environmental incident tracking, air quality equipment monitoring, compliance enforcement activity, land buy back initiatives, leases and rights-of-way, enrollment/blood quantum, revenue distributions, Resolutions and Ordinances, tribal elections, and procurement; and
- WHEREAS, A central data base accessible to the Tribal Business Council and authorized departments will streamline electronic processes for more accurate and timely reports, improve efficiencies and better manage information flow; and
- WHEREAS, XTIRI is a Utah based technology company specializing in helping Indian Tribes optimize and manage data, and can provide the necessary central data based technology system and assist the MHA Nation with its implementation
- NOW THEREFORE BE IT RESOLVED, That the Tribal Business Council hereby authorizes the Chairman to execute, subject to legal review, an agreement with XTIRI consistent with terms and intent of this Resolution, and to take such further action to implement the agreement consistent with the terms and intent of this Resolution.
