

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled, "Authorizing Construction Contract and General Contractor for Trailer Park Facility in Twin Buttes, North Dakota"

- WHEREAS, The Mandan Hidatsa and Arikara Nation ("Nation" or "Tribes") having accepted the Indian Reorganization Act of June 18, 1934 ("IRA"), and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and
- WHEREAS, The Constitution of the Nation generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article III, Section 1 of the Constitution of the Nation provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Article VI, Section 5(c) of the Constitution of the MHA Nation specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Nation and to make expenditures from available Tribal funds for public purposes for the Nation; and
- WHEREAS, The Tribal Business Council desires to authorize the construction of a trailer park facility in Twin Buttes (the "Project"); and
- WHEREAS, In order to avoid mobilization costs, the MHA Nation Construction Management Department negotiated a construction contract with Meyer Contracting, Inc. a contractor currently engaged in construction work at Twin Buttes, in the amount of \$443,160; and
- WHEREAS, A contract in the amount of \$443,160 for the Project has been presented for approval on a standard AIA Form (A104-2017), a copy of which is attached hereto (the "Contract").
- NOW THEREFORE BE IT RESOLVED, the Tribal Business Council authorizes the Contract, subject to legal review, in the amount of \$443,160 and waives the requirements of the Procurement Policy.
- **BE IT FINALLY RESOLVED**, Subject to legal review, the Tribal Chairman is hereby authorized execute the Contract, and to take such action as is necessary to carry out the terms and intent of this Resolution.
