

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- A Resolution entitled, "Approval of the Tribal Business Council's Appointment for the Communication Board by the Twin Buttes Segment Representative"
- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, Article III, of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Article VI, Section 5 (1) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business and other Tribal agencies and Tribal officials on the Reservation; and
- WHEREAS, The Tribal Business Council has established several Tribal Boards and Commissions by tribal ordinance and charters to oversee and administer various tribal programs and entities on the Fort Berthold Indian Reservation, including the MHA Communications Board of Directors, The TERO Commission, the Fort Berthold Housing Aurthority Board of Commissioners, the Fort Berthold Community College Board of Directors; and
- WHEREAS, Pursuant to the charters and ordinances establishing theses boards and commissions such boards and commissions consist of seven members with one member appointed from each Tribal Council Segment Representative and one from the Tribal Chairman to serve four year terms consistent with the term of the appointing council member; and
- WHEREAS, Cory Spotted Bear is the Twin Buttes Segment Tribal Council Representative and requests the Tribal Business Council to approve the appointment of Julie Beston to serve on the Communications Board.
- NOW THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes herby ratifies the appointment of Julie Beston to serve as the Twin Buttes Segment Representative to the Communication Board; and
- **BE IT FURTER RESOLVED,** that said appointment shall be for a term consistent with the term of office of the Twin Buttes Segment Representative to the Tribal Business Council or until Julie Beston is replaced by another appointee.
