



**RESOLUTION OF THE GOVERNING BODY
OF THE
THREE AFFILIATED TRIBES
OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled, “*Approval of Corporate Credit Card for the Animal Control Division.*”

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and

WHEREAS, The Constitution and By-laws of the Three Affiliated Tribes (Tribe) was adopted by membership of the Tribe on May 15th, 1936 pursuant to the Indian Reorganization Act of 1934 and duly approved by the Secretary of Interior; and

WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribe and of the enrolled members thereof; and

WHEREAS, Pursuant to Article VI, Section 5 (1) of said constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and

WHEREAS, Article VI, Section 5 (c) of the Constitution of the Three Affiliated Tribes Specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purposes of the Tribe; and

WHEREAS, Animal Control Division seeks to provide efficient and timely veterinarian services to the animals that are in its care; and

WHEREAS, For Animal Control Division to fulfill its duty to provide efficient and timely services to the animals in its care, the agency has requested permission to obtain a credit card with a two thousand-dollar (\$2,000) credit limit to ensure it provides veterinarian services in a timely manner. The credit card shall only be used to obtain veterinarian services for animals in its care, and the Three Affiliated Tribes’ Tribal Business Council agrees with this request; and



NOW THEREFORE BE IT RESOLVED, That the Tribal Business Council hereby authorizes Animal Control Division to obtain a credit card with the credit limit of two thousand dollars (\$2,000); and

BE IT FUTHER RESOLVED, That said credit card shall be used for organizational purposes of the Animal Control Division, and not in the name of any individual employee; and

BE IT FUTHER RESOLVED, That the Animal Control Division shall develop a written policy governing the use and misuse of said credit cards; and

BE IT FUTHER RESOLVED, That said credit card shall not be used at any time for personal use and any such unauthorized uses will result in automatic payroll deductions and other appropriate disciplinary action; and

BE IT FUTHER RESOLVED, That the Animal Control Division Director shall be responsible for the management of said credit card.


CERTIFICATION
