



**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution Entitled: "Approval of Home Site Leases and Utility Corridor for Tana Dixon"

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribe generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies; and

WHEREAS, The Three Affiliated Tribes has authority to approve of land transactions on tribal land.

WHEREAS, The Three Affiliated Tribes finds it beneficial to provide for use of tribal lands for homesite and residential lease.

NOW THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes approves the following home site leases and Utility Corridors for the following individuals for a period of 25 years at a rate of \$50 per year:

1. Tana Dixon Tribal Home Site Lease, located in the East Segment for 2.5 acres on Tribal Allotment T 222A, NE $\frac{1}{4}$ NW $\frac{1}{4}$ SW $\frac{1}{2}$ SW $\frac{1}{4}$, Section 8, T. 148 N., R. 90 W., McLean County, 5th PM of North Dakota, U.S.A.
 - 1) Tana Dixon Home Site and the Fort Berthold Rural Water will be constructing a Service Line in the East Segment. The easement will run a service line to a home site being built in the East Segment, across Tribal lands.
 - 2) Tana Dixon Home Site and the McLean Electric Cooperative will be constructing a Service Line in the East Segment. The easement will run a service line to a home site being built in the East Segment, across Tribal lands.
 - 3) Tana Dixon Home Site and the Reservation Telephone Cooperative will be constructing a Service Line in the East Segment. The easement will run a service line to a home site being built in the East Segment, across Tribal lands.
 - 4) Tana Dixon Home Site and the Three Affiliated Tribes Roads Department will be constructing an access road in the East Segment. The easement will run a service line to a home site being built in the East Segment, across Tribal lands.



- 5) Tana Dixon Home Site and the Three Affiliated Tribes Public Works Department will be constructing a service line & septic system in the East Segment. The easement will run a service line to a home site being built in the East Segment, across Tribal lands.

BE IT FURTHER RESOLVED that any of the Tribal Executive Officers may sign aforementioned lease documents on behalf of the tribe for the transactions above.
