



**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled, "*Approval of the Consultant Contract of T.W. Enterprises for the annual maintenance services for generators*"

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and

WHEREAS, The Constitution and By-laws of the Three Affiliated Tribes was adopted by membership of the Tribes on May 15th, 1936 pursuant to the Indian Reorganization Act of 1934 and duly approved by the Secretary of Interior; and

WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, there are generators installed at five buildings which house Tribal programs; and

WHEREAS, the T.W. Enterprises company will perform annual service and maintenance of the generators as outlined in the agreement;

NOW BE IT FURTHER RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby approves the funding for the service and maintenance of the generators located at the MHA Energy building, MHA Office Complex, TAT Dental Clinic, EMHC, and the TAT Administration building.

NOW BE IT FINALLY RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby approves the funding for the maintenance and service of the five generators for a total of \$7,522.49 per agreement.

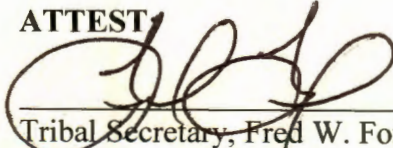
CERTIFICATION

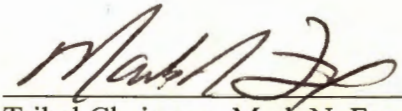
