

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

## A Resolution Entitled, "Approving and Appropriating Funds for Restoration and Maintenance of Queen of Peace Cemetery"

- WHEREAS, The Mandan Hidatsa and Arikara Nation (MHA Nation), also known as the Three Affiliated Tribes, having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and Bylaws under said Act, and
- WHEREAS, Pursuant to Article III, Section 1 of its Constitution and By-Laws, the Tribal Business Council is the governing body of the MHA Nation; and
- WHEREAS, Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt Resolutions regulating the procedures of the Tribal Business Council, its agencies and officials; and
- **WHEREAS,** The MHA Nation is in negotiations for an easement across allotment number 2075; and
- WHEREAS, The owners of allotment number 2075 have requested that funds be set aside for the restoration of Queen of Peace Cemetery; and
- WHEREAS, The FBRW has created a budget, attached as Attachment 1 to this Resolution, for the restoration and annual upkeep of the Oueen of Peace Cemetery.
- NOW THEREFORE BE IT RESOLVED, The MHA Nation appropriates the necessary funding for the restoration and upkeep of the Queen of Peace Cemetery as shown in Attachment 1.
- **BE IT FURTHER RESOLVED,** That funds shall be appropriated each year in the amount shown in **Attachment 1** for the annual upkeep of the Queen of Peace Cemetery.
- **BE IT FINALLY RESOLVED,** The Tribal Chairman is hereby authorized to take such action as is necessary to carry out the terms and intent of this Resolution.
