



**RESOLUTION OF THE GOVERNING BODY  
OF THE  
THREE AFFILIATED TRIBES  
OF THE  
FORT BERTHOLD INDIAN RESERVATION**

*A Resolution Entitled "Approval of the Relinquishment of Trey Lewis LeBeau Enrollment Number 301U-11254 from Membership in the Three Affiliated Tribes"*

**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and

**WHEREAS,** Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

**WHEREAS,** The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

**WHEREAS,** The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls; and

**WHEREAS,** Trey Lewis LeBeau Enrollment Number 301U-11254 DOB: 04/29/1999 has requested to be Relinquished from the Three Affiliated Tribes on December 20, 2018; and

**WHEREAS,** Trey Lewis LeBeau Enrollment Number 301U-11254 DOB: 04/29/1999 is an adult over the age of eighteen (18) years at the time of their relinquishment request; and

**NOW THEREFORE BE IT RESOLVED,** by the Tribal Business Council of the Three Affiliated Tribes that Trey Lewis LeBeau Enrollment Number 301U-11254 DOB: 04/29/1999 is hereby Relinquished from the official membership roll of the Three Affiliated Tribes; and

**BE IT FINALLY RESOLVED** that Trey Lewis LeBeau Enrollment Number 301U-11254 DOB: 04/29/1999 shall be removed from the official membership roll of the Three Affiliated Tribes upon the approval of this resolution by the Tribal Business Council of the Three Affiliated Tribes.




**CERTIFICATION**


