



**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled, "Consent to Certain Rights of Way across Tribal land for the Livestock Watering System"

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and

WHEREAS, Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and

WHEREAS, Article IX Sections 1 and 3 of the Constitution provides that the Tribal Business Council has the authority to manage and lease or otherwise deal with tribal lands and resources; and

WHEREAS, The applications for Rights of Way described herein have been reviewed and recommended for approval in accordance with the MHA Nation's approved procedure for authorizing ROWs on tribal land; and

WHEREAS, The Tribal Business Council finds it appropriate to authorize the ROWs described herein.

NOW THEREFORE BE IT RESOLVED, the Business Council hereby consents to the following ROW(s):

Pete Fredericks, 301U0000, in the **South Segment**, request an easement for a livestock watering system, as shown on detail maps (attached), across certain tribal lands in:

- a. Allotment Number **T1816, E½NE¼, Section 34; W½SW¼, NW¼, Section 35, T. 147 N., R. 92 W.**, Dunn County, 5th Principal Meridian of North Dakota, with a **100%** Tribal interest, as more particularly described in Appendix A.1

b. Allotment Number T2150, E½, Section 27, T. 147 N., R. 92 W, Dunn County, 5th Principal Meridian of North Dakota, with a 100% Tribal interest, as more particularly described in Appendix A.2

BE IT FINALLY RESOLVED, that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.


CERTIFICATION


