



**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled, "Authorization for a one-time Disbursement of Funds from Tribal Oil & Gas Royalty Revenues to All Enrolled Members of the Three Affiliated Tribes"

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, Article VI, Section 5 (c) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to administer any funds or property within the exclusive control of Tribes and to make expenditures from available tribal funds for public purposes of the Tribes; and

WHEREAS, The Three Affiliated Tribes have benefitted greatly from the oil & gas development and activity on the Fort Berthold Indian Reservation; and

WHEREAS, The Tribal Business Council wishes to provide the enrolled membership with a disbursement of the Tribes' oil & gas royalty revenues.

THEREFORE BE IT RESOLVED, The Tribal Business Council of the Three Affiliated Tribes hereby formally approves a one-time disbursement of funds from oil & gas royalty revenues to all enrolled members of the Three Affiliated Tribes; and

BE IT FURTHER RESOLVED, Each enrolled member of the Three Affiliated Tribes as of April 12, 2019 and regardless of age shall receive a one-time disbursement in the amount of one thousand dollars (\$1,000.00); and

BE IT FURTHER RESOLVED, Any delinquent monies owed to Tribal Finance, to Tribal Loan Departments and to Three Affiliated Tribes Division of Child Support Enforcement, shall be deducted from this distribution at the rate of \$500.00 for Finance, \$500.00 for loans and \$500.00 for TATDCSE.

BE IT FURTHER RESOLVED, Enrolled members under the age of 14 as of August 1, 2019 will be required to have a legal guardian fill out an "instruction for disbursement



form” and return to finance. Forms will be available at Tribal Finance, segment offices and the MHA website.

BE IT FURTHER RESOLVED, Enrolled members under the age of 14 as of August 1, 2019 that do not have a completed “instruction for disbursement form” returned to Tribal Finance by August 1, 2019 will have disbursement held in an investment account until the age of 18.

BE IT FURTHER RESOLVED, Enrolled members under the age of 14 as of August 1, 2019 in the custody of The Three Affiliated Tribes and ICWA shall have their disbursement held in an investment account until the age of 18.

BE IT FURTHER RESOLVED, The authorized one-time disbursement shall be taken exclusively from existing oil & gas royalty revenues of the Three Affiliated Tribes; and

BE IT FURTHER RESOLVED, No funds for the one-time disbursement approved by this Resolution shall be taken from any funds on deposit for the benefit of the *Nuxbaaga Iidaa Uuh Waa Zaah, Sahnis waaplsis, Aki numuk aki tawatesh sha geddish, The People's Fund*; and

BE IT FURTHER RESOLVED, The Chief Financial Officer of the Three Affiliated Tribes shall work to identify the appropriate accounts and to make ready for issuance of the one-time disbursement in accordance with this Resolution; and

BE IT FINALLY RESOLVED, The Disbursement authorized by this Resolution shall be sent via U.S. Mail to the last known address of the individual no later than April 26, 2019.




CERTIFICATION


