



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

*A Resolution entitled, "Consent to Certain Rights of Way across Tribal land for the  
McKenzie Electric Cooperative"*

**WHEREAS**, This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and

**WHEREAS**, Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and

**WHEREAS**, Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and

**WHEREAS**, Article IX Sections 1 and 3 of the Constitution provides that the Tribal Business Council has the authority to manage and lease or otherwise deal with tribal lands and resources; and

**WHEREAS**, The applications for Rights of Way described herein have been reviewed and recommended for approval in accordance with the MHA Nation's approved procedure for authorizing ROWs on tribal land; and

**WHEREAS**, The Tribal Business Council finds it appropriate to authorize the ROWs described herein.

**NOW THEREFORE BE IT RESOLVED**, the Business Council hereby consents to the following ROW(s):

1. McKenzie Electric Cooperative will be constructing an Electrical Service Line in Four Bears Segment. The easement will run a variable width for Three Phase Power lines, for the new Tribal Administration Building in the Four Bears Segment, across certain tribal lands in:

a. Allotment Number T549A, Section, 16, T. 152 N., R. 93 W., McKenzie County, 5<sup>th</sup> Principal Meridian of North Dakota, with a 100% Tribal interest, offered value according to MEC Board Policy 103.

2. McKenzie Electric Cooperative will also be constructing an Electrical Service Line in the West Segment. The easement will run a variable width for Three Phase Power lines, for the Water



Treatment plant service line and the new Mandaree High School Building in the West Segment, across certain Tribal lands in:

- a. Allotment Number 696A-A, W $\frac{1}{2}$ SW $\frac{1}{4}$ , Section 11, T. 149 N., R. 94 W., McKenzie County, 5<sup>th</sup> Principal Meridian of North Dakota, with a .0002314814 Tribal interest, offered value according to MEC Board Policy 103.
- b. Allotment Number T696A-C, SE $\frac{1}{4}$ , NE $\frac{1}{4}$ SW $\frac{1}{4}$ , Section 11, T. 149 N., R. 94 W., McKenzie County, 5<sup>th</sup> Principal Meridian of North Dakota, with a 100% Tribal interest, offered value according to MEC Board Policy 103.
- c. Allotment Number T696A-B, SE $\frac{1}{4}$ SW $\frac{1}{4}$ , Section 11, T. 149 N., R. 94 W., McKenzie County, 5<sup>th</sup> Principal Meridian of North Dakota, with a 100% Tribal interest, offered value according to MEC Board Policy 103.




**CERTIFICATION**
