

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Approval of Consultant Contract between TAT Division of Child Support Enforcement and Thomson Reuters"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, Pursuant Article III., Section 1 of the Constitution and By Laws of the Three Affiliated Tribes (or "Tribes"), the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Tribal Business Council has authority to engage in activities on behalf of and for the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Tribal Business Council has authority to make expenditures from available Tribal finds for public purposes of the Tribes; and
- WHEREAS, Pursuant to Article VI, Section 5 (1) of the Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures for Tribal Agencies; and
- WHEREAS, The TAT Division of Child Support Enforcement (TAT DCSE) desires to enter into a Consultant Contract for the purpose of location services for the TAT DCSE's current Child Support matters; and
- WHEREAS, Thomson Reuters is knowledgeable in the support functions of location services for the TAT DCSE.
- NOW, THEREFORE, BE IT RESOLVED that the Tribal Business Council of the Three Affiliated Tribes hereby approves TAT DCSE entering into a consultant contract with Thomson Reuters to provide location assistance pursuant to Child Support Services Contract; and
- **BE IT FURTHER RESOLVED** that such services shall be compensated at the monthly rate of Two Hundred Fifty Seven Dollars (\$257.00), and the total contract is not to exceed Ten Thousand Dollars (\$10,000.00) for the Thirty Six (36) month term ending September 30, 2022; and
- **BE IT FINALLY RESOLVED** that the Director of the TAT Division of Child Support Enforcement (TAT DCSE) is authorized to execute and enter into a consulting agreement consistent with this Resolution.
