

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Land Ownership Record Change to Three Affiliated Tribes"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Three Affiliated Tribes (or "Tribes") Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and
- WHEREAS, Article IX Sections 1 and 3 of the Constitution provide that the Tribal Business Council has the authority to manage and lease or otherwise deal with Tribal lands and resources; and
- WHEREAS, It has come to the attention of the Tribal Business Council that some real property (Fee Patent Land) bought with Tribal funds is currently in the name of other entities of the Tribes, including entities which are defunct or are no longer active; and
- WHEREAS, The Tribal Business Council has determined that it is in the best interests of the Tribes and its enrolled members to ensure that all official records of such Fee Patent lands acquired with Tribal funds show the record owner to be the Three Affiliated Tribes; and
- WHEREAS, The Tribal Business Council has determined it is in the best interests of the Tribes and its members that any records of Fee Patent lands acquired with Tribal funds indicating an owner other than the Tribes be corrected and changed to show the Three Affiliated Tribes as record owner;
- NOW, THEREFORE, BE IT RESOLVED that although current records may indicate other entities as owners, the Three Affiliated Tribes' Tribal Business Council hereby declares and reaffirms all of the following property was acquired with Tribal funds and that the Three Affiliated Tribes retains ownership of the following said property:

**BE IT FURTHER RESOLVED** that the Natural Resources Department, the Tribes' Legal Department and all entities of the Tribes cooperate in ensuring that the records for the above properties be changed and corrected to indicate that the rightful owner, the Three Affiliated Tribes, is also the record owner by any lawful means necessary.



- **BE IT FURTHER RESOLVED** that the Three Affiliated Tribes' Tribal Business Council hereby authorizes and directs that all future Real Property Acquisitions be presented to the Natural Resource Committee prior to purchase for approval.
- **BE IT FINALLY RESOLVED** that the Tribal Business Council of the Three Affiliated Tribes hereby authorizes the Chairman of the Tribal Business Council, its Secretary, the Superintendent of the Fort Berthold Agency, the Area Director, and Commissioner of the Indian Affairs to prepare all documents and do all things necessary to transfer title of the aforementioned property to the United States of America, in trust for the Three Affiliated Tribes of the Fort Berthold Indian Reservation.
