



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

**A Resolution Entitled, “*Approval of Waiver of the TERO Employment Rights Fee for Construction Contracts – North Segment Projects.*”**

**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and

**WHEREAS,** Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

**WHEREAS,** The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

**WHEREAS,** Article VI, Section 5 (i) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to make arrangements and leases of Tribal Lands, and otherwise to manage Tribal Lands; and

**WHEREAS,** Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal Agencies and Tribal officials of the Reservation; and

**WHEREAS,** The Tribe is constructing new laundromat, quick lube and car wash facilities in the North Segment of the Reservation, in New Town N.D.; and

**WHEREAS,** Title VI – Section 601 of the TERO Ordinance requires a TERO Employment Rights Fee equal to two and one half percent (2 ½ %) for all construction projects on the Fort Berthold Indian Reservation; and

**WHEREAS,** The Tribal Business Council has reviewed the Tribal Projects and has determined it is in the best interests of the Tribe to approve a waiver of the two and one half (2 ½ %) MHA TERO Employment Rights Fee.

**NOW THEREFORE BE IT RESOLVED,** The Tribal Business Council of the Three Affiliated Tribes hereby approves a waiver of the two and one half (2 ½ %) MHA TERO Employment Rights Fee for the construction of the new laundromat, quick lube and car wash facilities in the North Segment of the Reservation, in New Town N.D.

**BE IT FURTHER RESOLVED,** The MHA TERO fee waiver shall only apply to the Employment Rights Fee for the new laundromat, quick lube and car wash facilities in the North Segment of the Reservation, in New Town N.D .



**BE IT FINALLY RESOLVED,** All companies, including but not limited to contractors, subcontractors and vendors involved in these projects shall be responsible for all applicable individual TERO license fees in accordance with the TERO Ordinance.


**CERTIFICATION**


