

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Consent to Certain Rights of Way across Tribal land for the McKenzie Electric Cooperative – Eagles Landing C Store"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and
- WHEREAS, Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes (or "Tribes"), the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and
- WHEREAS, Article IX, Sections 1 and 3 of the Constitution provide that the Tribal Business Council has the authority to manage and lease or otherwise deal with Tribal lands and resources; and
- WHEREAS, The applications for Rights of Way (ROWs) described herein have been reviewed and recommended for approval in accordance with the MHA Nation's approved procedure for authorizing ROWs on Tribal land; and
- **WHEREAS**, The Tribal Business Council finds it appropriate to authorize the ROWs described herein, and to waive payment in consideration of the public benefit the granting of the ROWs provides.
- NOW THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby waives payment and consents to the following ROW(s):
 - 1. McKenzie Electric Cooperative will be constructing an Electrical Service Line in Four Bears Segment. The easement will run a variable width for Three Phase Power lines, for the 4 Bears Eagles Landing Line Move in the Four Bears Segment across certain Tribal lands in:
 - a. Allotment T549A, Section 16, T152N, R93W, McKenzie County, 5th Principal Meridian of North Dakota, with a 100% Tribal interest, offered value according to MEC Board Policy 102.



- b. Allotment T5439, Section 15, T152N, R93W, McKenzie County, 5th Principal Meridian of North Dakota, with a 100% Tribal interest, offered value according to MEC Board Policy 102.
- **BE IT FINALLY RESOLVED,** that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.
