Motion by Adam Mandan, seconded by Adrian Foote to approve loan of Lee Fox, Sr., for funeral expense of \$40.00 to be paid from 1970 leases. Motion carried.

Motion by Adrian Foote, seconded by Ted Bolman, Jr., to confirm loan of Martha Lone Bear for funeral expenses for mother. Motion carried.

Motion by Adrian Foote, seconded by Alfred Driver, Sr., to approve George Buffalo's loan of \$30.00. Motion carried.

Motion by Adrian Foote, seconded by Alfred Driver, Sr., to approve loan for Leon Fox for \$25.00. Motion carried.

Motion by Adrian Foote, seconded by Alfred Driver, Sr., to approve loan of George Bruce, Sr., for \$50.00. Motion carried.

Solly Danks brought up a question on his lease. A lease that was not bid on and had negotiated for this lease that had been laying there and has already paid for his allocation and has money to pay for this land laying idle. Motion by Adrian Foote, seconded by Alfred Driver, Sr., for Land Chairman to get all information on this subject and bring the information back to the next meeting.

Adam Mandan read the proposed dog registration and rabies control ordinance and discussion followed on said ordinance. Motion by Adrian Foote, seconded by Tony Mandan to table the ordinance of dog control until the wording in Section 2 in Item (a) be reworded by Thomas Owens. Motion carried.
