

SPECIAL MEETING

Acting Chairman Nathan L. Soldier called the meeting to order. Roll Call: Ted Bolman, Jr., Philip Ross, Sr., Adam Mandan, Rose C. F. High, Alfred Driver, Sr., Nathan L. Soldier and Ralph Wells, Jr. Quorum present. Absent: Vincent Malnourie, Gerald Nagel and Adrian Foote. Adrian Foote Tardy.

First order of business was to have the Tribal Council take action on enrollment applications that have been acted on and approved by the Tribal Enrollment Committee and recommended to the Council for final approval.

Motion by Adam Mandan, seconded by Philip Ross, Sr., that the Council obey the restraining order to withdraw our police from the questioned area. Adam Mandan oriented the Council on the restraining order from New Town. Motion carried unanimously and Chairman not voting.

108 Motion by Rose C. F. High, seconded by Ted Bolman, Jr., to approve the land purchase of Triby Hale Deserly by the Tribe at the price of \$3,000.00. Motion carried. 5 for, 0 opposed, 2 abstained and Chairman not voting.

Motion by Ted Bolman, Jr., seconded by Rose C. F. High to have a resolution drawn up on the Tribe buying land from the Indians through FHA Loan and to have CAP personnel to inform the public. Remarks: It was asked who was going to handle the money. Motion carried unanimously.

A letter was read from Doctor Miner, IPHS, New Town, North Dakota, regarding the Councils' recommendation in hiring a plumber for New Town IPHS. Two applications were submitted to the Council for recommendation. The two applications were for Angus Fox and Thomas A. Wells.

Motion by Rose C. F. High, seconded by Alfred Driver, Sr., to recommend Thomas A. Wells application for work as a plumber being that the other applicant is a relative of mine and have been accused of hiring my own relatives. Motion carried. 4 for, 1 opposed, 2 abstained, and Chairman not voting.

Motion by Rose C. F. High, seconded by Alfred Driver, Sr., to approve Resolution No. 70-106 as written. Motion carried unanimously.

✓ Motion by Philip Ross, Sr., seconded by Rose C. F. High to approve Resolution No. 70-107 as written. Motion carried unanimously.

Motion by Ralph Wells, Jr., seconded by Adrian Foote to approve September 1, 1970 enrollment applications as presented by the Tribal Enrollment Committee. Motion carried.

Motion by Philip Ross, Sr., seconded by Rose C. F. High to approve September 2, 1970 enrollment applications as presented by the Tribal Enrollment Committee. Motion carried unanimously.

Motion by Adrian Foote, seconded by Alfred Driver, Sr., to approve enrollment applications of September 3, 1970 as presented by the Tribal Enrollment Committee. Motion carried unanimously.

← Motion by Adrian Foote, seconded by Rose C. F. High to approve Resolution No. 70-110 as written. Motion carried unanimously.

Motion by Rose C. F. High, seconded by Ralph Wells, Jr., that the old Council adjourn. Motion carried unanimously.
