Acting Chairman Nathan Little Soldier called meeting to order, 5:00 P.M.
Roll Call: Nathan Little Soldier, Gerald Nagel, Ralph Wells, Robert Bell, Robert Fox, James Bluestone, Nathan Lonefight and Adam Mandan
Absent: Vincent Malnourie

Purpose of meeting was to have Tribal Council authorize grazing permit allocations. Council met with Frank Whitehead and Duane Wagner from BIA hand operations.

Clarence Lincoln applying for allocation for 100 head of cattle. Motion By Tony Mandan to approve the allocation for Clarence Lincoln. Motion carried . 7 for 0 opposed. Chairman not voting.

Malcom Bruce applying for an allocation.

Eugene Voight applying for an allocation.

Motion by Robert Fox seconded by Gerald Nagel to approve allocation applied for by Eugene Voight. Motion carried , 6 for 0 opposed. Chairman not voting.

Lonnie Spotted Bear applying for an allocation. Motion by Gerald Nagel to have the Superintendent exercise his normal procedure in this special case of with drawl of land. Which is his own or which his family owns.

Wayne Moran applying for an allocation . Motion by Gerald Nagel and seconded Myra Snow to approve the allocation for Wayne Moran to have the BIA work out a workable lease on this allocation.

Motion carried 6 for 1 opposed, chairman not voting, application applied for by Mary Halverson for an allocation.

Motion by Gerald seconded by Jim Bluestone to approve allocation of Malcom Bruce providing that he has the money to be looked into by land operations. Motion carried, 7 for and 0 opposed, 1 abstained.

Motion by Robert Fox and seconded by Bobby Bell to have BIA solve the allocation out on Malcom Bruce allocation.

Mary Halverson applying for an application for 125 head was discussed by the Tribal Council. Motion made by Tony Mandan to leave the leasing to the Superintendent and his experts work out the allocations pending. Motion died of second.

Motion by Gerald Nagel seconded by Ralph Wells to disapprove the allocation due to the unbonafide evidence of ownership . No Money. Motion carried 8 for 0 opposed, Chairman not voting.

Gerald Nagel applying for an allocation . Remarks FHA loan to go to State FHA office for approval yet.

Jim Bluestone made a motion to approve Gerald Nagels allocation for 150 head, seconded by Bob Fox. Motion carried, 7 for, 0 opposed., 1 abstained.

Application applied for by Inez Chase for an application for an allocation. Motion made by Bob Fox and Seconded by Myra Snow to approve allocation for Inez Chase. Motion carried.

Paige Baker applying for allocation for 102 head of cattle to approve Paige Baker's request for an allocation for 102 head of cattle. Motion carried 8 for 0 opposed. Chairman not voting.

Allocation requested by Stones for range unit. Motion By Robert Fox and seconded by Nathan Lonefight to approve allocation request of the Stone's on unit. 52 motion carried 7 for 0 opposed. Chairman not voting.

Motion made by Myra Snow and seconded by Nathan Lonefight to disapprove Willard Little Owl's allocation. Motion carried, 6 for, 0 opposed, 1 abstained

Mr. Berry Halfred asked about the log house west of the Four Bears Complex he was referred to the realty department for more information.

Motion made by Bobby Bell, seconded by Gerald Nagel to give 1 Buffalo to the Northeast segment. Motion carried unanimously.

Berry Halfred came in and stated that the log house went with the land.

Delvin Foote requested for an allocation on units 51-48-33. No loan. Nathan Lonefight made a motion and was seconded that the application is denied due to lack of no credit evidence to purchase livestock and due to lack of time for consideration. Motion carried 7 for 0 opposed.

Motion made by Nathan Lonefight and seconded by Tony Mandan to disapprove Howard Wilkinson's hay cutting permit. 7 for, 0 opposed. Motion carried.

Marian Fisher applied for an allocation. Motion made by Gerald Nagel and seconded by Jim Bluestone to approve the allocation, if she has evidence of ownership same as Malcom Bruce.

Kingdom Black Hawk and Thomas B. Haks allocation of 20 unit. Motion made by Tony Mandan and seconded by Bob Fox to approve the allocation. Motion carried. 8 for, 0 opposed.

Motion was made and seconded to approve Ted Lonefight's allocation. Motion carried unanimously.

Matthew YoungBird applying for an allocation on unit. Motion by Tony Mandan seconded by Nathan Lonefight to approve allocation subject to evidence. Motion carried unanimously.

Bill Hall applying for an allocation. Motion made and seconded to approve allocation subject to FHA approval. Motion carried unanimously.

Mervel Hall and Jim Johnson applying for allocation. Jim Johnson no loan approval yet for purchase of cattle from FHA. Mervel Hall must have his own loan coming from other sources to purchase cattle, not from FHA. Motion made by Tony Mandan and seconded by Robert Fox to leave these requests on allocations to the BIA thru BIA land operations on applications.

Motion made by Robert Fox and seconded by Jim Bluestone to approve annual leave for 2 days for Marie Wells. Motion carried unanimously.

Ivan Youngbear requested a release of funds to take a child of his to Denver. He was told by the Council to come back Monday and get something worked out.

The Tribal Council decided to keep previous decision on Tom Wells. Silas Howling Wolf's application was discussed. No motion needed on the application.

On Tuesday night on September 29, 1970 meeting by Myra Snow to contact Hazel Blake to send out notices on the meeting scheduled.

Gerald Nagel attend meeting September 30 to October 3, 1970. Statler Hilton Hotel. Nagel gave highlights on the industrial meeting in Detroit, Michigan. Bluestone to work out the travel.

Motion made by Bob Fox and Seconded by Nathan Lonefight to authorize Bobby Bell to go to the meeting in Detroit, finance to come from Tribal Funds. Jim Bluestone, Jerry Nagel, and Dale McGrady attend the meeting.
