# TRIBAL COUNCIL MEETING

Tribal Council Members present: Robert Bell, Vincent Malnourie, Adam Mandan, Nathan Lonefight, Gerry Nagel, and Ralph Wells. Council members absent: Myra Snow, Nathan Little Soldier and James Bluestone. Others present: Ted Bolman Mr. Goss.

Chairman called the meeting to order. Secretary took roll call.

Ted Bolman stated that there were job openings now available at the Four Bears Complex and notices were being sent out. (See attached announcement)

Discussions were held on correspondence received by the Tribal Council.

Letter from Straus concerning training for tribal members at the Four Bears Motel, on the job training.

Letter from Joe Satrom, Travel Director stating that there will be a Lewis & Clark committee meeing held at the Highway Dept. in Bismarck at 10:00 A.M. Monday, 26 October 1970. The committee requested that one Tribal Council Member attend and be one of the voting members for the Lewis & Clark Trail Council.

Letter from Wilkinson, Cragun and Barker was in reference to S.774 Bill, which would mortage tribal lands purchased in the future, the letter also stated if the Bill didn't pass this Congress, it had an excellent chance of passing in early 1971 during the next congress.

Letter from Twin Buttes, the people living in low rent housing made a request for speed limit signs for their childrens welfare

Letter from Baron Halfred, Field Engineer, he suggested that the local Housing Authority should be represented as a commission member and that provisions be made for maintenance in homes that have wells and septic tanks. He also mentioned shortage of maintenance men in the five segments.

Malnourie requested that the people renting or owning low rent houses were able to fix their homes and get paid for it.

Mandan stated that if the people had the experience and were qualified they could stay at home and work on their houses and get paid for it.

Phone call from Straus about the Boundary Dispute, Council meet with Judge registrar on the 26th of October. Court would probably be held in Nov. or Dec. and that BIA police would have jurisdiction in Parshall but not in New Town, and that if the council wanted to meet with him here around the 27th of Oct. he'd be available.

Motion made by Mandan that Straus meet with the Tribal Council. Motion seconded by Robert Fox. 6 for, 0 opposed. Remarks: Nagel stated that the Tribe pay for a portion of Straus' expenses.

Ewald notified the Tribal Council of the meeting scheduled on the 25 of Oct thru the 28th, held in New Mexico.

Wells stated the Valandra needs two men for the road department in White Shield since Eugene White was transferred and if funds could come from Mainstream or TWEP.

Robert Fox added that Arnold Charging needed one man also

Mr. Goss stated that he and Mrs. Breslen had applications available. Requirments: Eligible for general assistance and unemployed. Personal interview for approval. He also said that there was a job position available. Salary, \$5,800 per yr.; Duties; Bookkeeping, making checks, checking on employment; no civil service test required; Tribal council will do the hiring; cut off date 190ct70.

Robert Fox made a motion to authorize the police department to purchase a new washer since theirs burnt down. Malnourie seconded the motion. 5 for, 0 opposed. Motion carried. Chairman not voting.

Robert Heart's loan was disapproved of due to the fact that he had no colateral. Motion was made by Tony Mandan to approve Ben Heart's loan for \$500.00. Bell seconded the motion. 6 for , 0 opposed. Motion carried. Chairman not voting.

The Chairman suggested that Adam Mandan assist Tribal Treasurer, Bobby Bell and sign checks for the Four Bears Complex and have Tony Mandan bonded for \$50,000 for the Four Bears Complex until Bell can get bonded from another company.

Discussion was held on the complaints made by the CHR Director about Betty Fredericks. Tribal Council asked Mrs. Fredericks' questions about her work. Mrs. Fredericks was excused from the meeting. Nagel made a motion to reinstate her. Motion seconded by Malnourie. 6 for, 0 opposed. Chairman not voting. Chairman stated that the Tribal Council will have to have a meeting with the CHR in the very near future. Chairman told Mrs. Fredericks that the Council went on record to reinstate her and give her another chance and try to readjust her home life. Nagel told Mrs. Fredericks that she had to try extra hard to proof herself worthy of the job, and talk with her husband about her responsibilities, meeting, transportation, etc.

Motion was made by Robert Bell to have Tony Mandan as an assistant to sign checks until he was bonded. Motion Seconded by Nathan Lonefight. 5 for, 0 composed. Chairman not voting. Motion Carried.

Motion was made by Tony Mandan to pass Resolution No. 70-113. Motion was 3 seconded . 6 for, 0 opposed. Chairman not voting. (See attached Resolution.

Motion was made by Malnourie to approve of Richard Wilkinson's hay cutting permit, seconded by Robert Fox. 5 for, 1 opposed. Chairman not voting. Motion carried.

Chairman authorized Gerald Nagel to check into the matter pertaining to the two letters received from Dallas Brien.

Motion was made by Robert Fox to reimburse Paul Ewald for the lumber purchase, amount \$45.22. Motion was seconded. 5 for, 0 opposed.

Motion made by Robert Fox to give Marie Wells and Hazel Blake 8 hours annual leave. Motion seconded by Tony Mandan, 6 for 0 opposed. Chairman not voting. Motion carried.

Motion was made by Malnourie that Gloria Wilkinson represent the Three Affiliated tribes in the Miss NCAI contest and be sponsored by any organization that would finance her transportation and lodging during the convention since the Tribe has no funds available and that the tribe would pay for the phone calls since she'd be representing the Three Affiliated Tribes and will also be looking for funds for one of the Tribal Council Members to attend the convention. Motion seconded by Robert Fox. 6 for, 0 opposed. Chairman not voting. Motion carried.

The Chairman scheduled a special meeting for Monday at 10:00, 120ct70, and that all Tribal Council Members be present and that the Health Committee meet with the Mandaree Vista Worker at 1:00.

Discussion was held on a model resolution to be drawn up and revised by the Tribal Council. Chairman and Secretary have set salaries and schedule meetings. Each Tribal Council member specialize in one department, for example, Law & Order Credit, Land, and etc., and have a job on the side.

Malnourie made a motion to authorize the Chairman to check into the finances to purchase a police car. Motion seconded by Nagel. 6 for 0 opposed. Chairman not voting. Motion carried.

Motion by Malnourie and seconded by Robert Fox to adjourn the meeting.
