Minutes of 2/6/76 were presented and read for approval. Myra Snow moved, second by B ernard Chase Jr., to approve as read. Chairperson not voting. All in favor, motion carried.

Hazel Blake arrived at 1:46 PM.

Minutes of 2/18/76 were presented and read for approval. John Stone Sr., moved, second by Tom Eagle Jr., to approve as read. Chairperson not voting. All in favor, motion carried.

Frank Fox Jr: Read a letter from Laverne Jessen, Dickinson State College asking for a supplementary of funds from the Tribe. The college granted thru CETA \$10,000 for salary - further explained his need. Ron Little Owl commented on Mr. Fox's statement. Hazel Blake suggested to ask the Community College. Tom Eagle Jr. stated that funds in the Community College are set for the Reservation only. A letter to itemized the reasons for either the tribe, can help or can't help thru the various sources that have been discussed. Tom Schoppert would write a letter to the State Board to Dick McGree for assistance. Also letter would be written to Link, Raymond-, Duane Lawrence for assistance for Frank Fox. Sam Little Owl moved, second by Bernard Chase Jr. to have Tom Schoppert write letter. Chairperson not voting. 1 opposed, 7 for. Motion carried.

Hazel Blake moved to use what is left of the Business Manager's funds after the contract is revised, second by Sam Little Owl. Chairperson not voting. 1 abstention, 7 for. Motion carried.

Larry Burr: Stated he would write to the DSC Alumni.

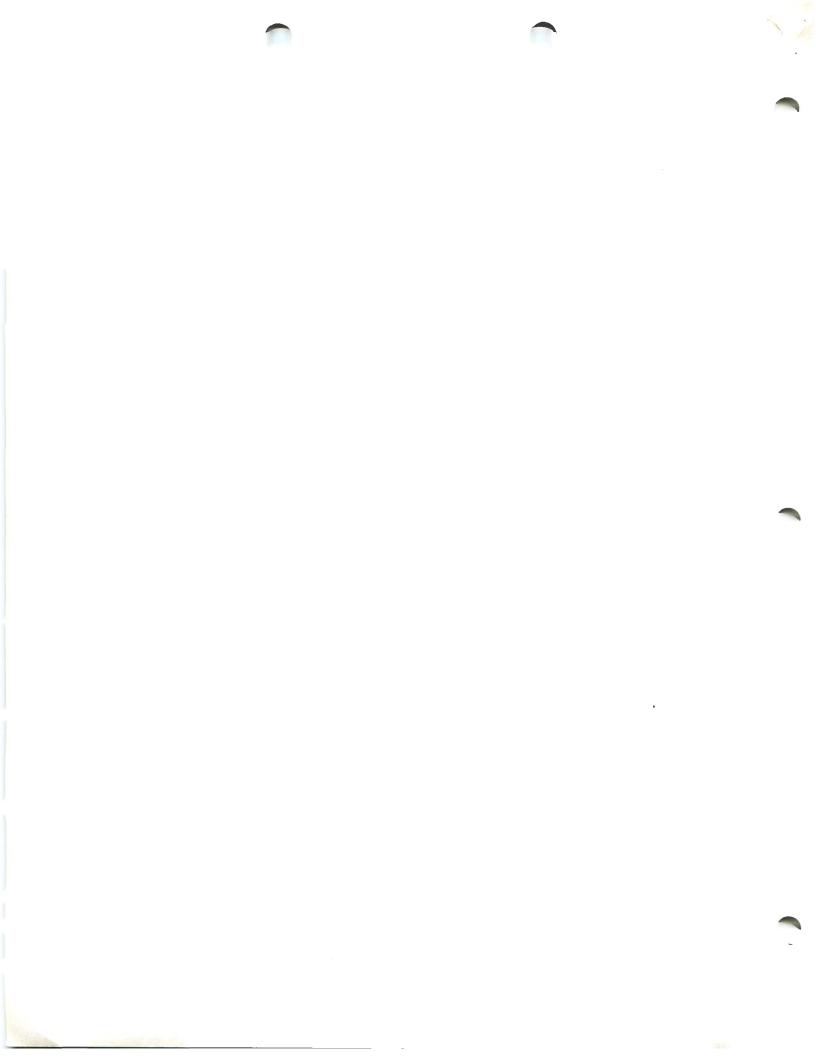

Tom Eagle Jr. moved, second by Austin Gillette to write a letter to Mr. Eaton, stating that the Tribe would appreciate any contributions from him. Chairperson not voting. All in favor, Chairperson not voting. Motion carried.

Call from Aberdeen stating they want transcript of Judgement Fund Hearing 2/2/76 from the Tribe, and also Cletus Medicine Crow wants permission to sent transcript on plane to Aberdeen. Sam Little Owl, second by Hazel Blake to approve. Chairperson not voting. All in favor, motion carried.

Austin Gillette moved, second by John Stone Sr. to have Chairwoman-Rose Crow Flies High attent NICA Meeting 2-23 thru 2-26 in Albuqerque NM. All in favor, motion carried.

Larry Burr requested a special meeting with council on land sales, etc. on March 30 or 31st. Bernard Chase Jr. moved, second by John Stone Sr. to approve. Chairperson not voting. All in favor, motion carried.

Tom Eagle Jr.: Reported there was \$18,000.00 in budget treasury.

Bernard Chase Jr. moved, second by Austin Gillette to have Sam Little Owl go to Bismarck and attend Roads meeting, February 23, 1976. All in favor, Chairperson not voting. Motion carried.
