Meeting was called to order by Rose Crow Flies High, Chairperson, at 10:30 a.m.

Establishment of a quorum.

ROLL CALL: Rose Crow Flies High, Chairperson; Ronald Little Owl, Vice-Chairman; Hazel Blake, Secretary; Roy Bird Bear, Treasurer. Council members: Larry Rush, Eva Beaks, Ralph Bird Bear, Wayne Packineau and Thomas Eagle, Jr. Quorum present. Absent: Austin Gillette and John Stone. Sr. Others present: Acting Supt. Donald Morgan and his staff -Mr. Fisher, Mr. Kirkaldie, Wilbur Wilkinson, John Danks and Larry Burr - Bill Lockwood, Chaplin; Waldron Crows Breast, Sergeant-atarms and all the directors of all Tribal Programs.

Prayer by Bill Lockwood.

Mr. Fisher, Director of Human Resources was granted the floor first. Mr. Beechie is the Social Service representative which staffs four ((4) people, two are Tribal employees. The social workers are Darlen Finley for Mandaree, Mary Schoppet for White Shield and Sharon Crows Heart for Twin Buttes. T.W.E.P. and the commodity program are contracted with the Tribe. There is no director for Employment Assistence yet and it is not necessary to have one. Anyone from the age of 18 to 35 years old are eligible for vocational training, and the courses go up to 24 months. The registered nurse programs is up to 36 months at U.N.D. in Williston, North Dakota. Mr. Gregory takes care of the Higher Education Grants. To be eligible, a person has to be living near or on the reservation and also, be an enrolled member of the Fort Berthold Reservation. There are no transportation fees for the college students. The Cripple Children program is worked with the State. The State sets the standards for the Food Program.

Ben Kirkaldie and Larry Burr, Trust Naural Resources Officer. There are Ten (10) people working with them. They take care of the land sales, leases and etc. For land sales, a resolution is drawn up and taken before the Tribal Business Council, for their approval of disapproval. The Superintendent is the Trust Officer for all minors concerning land, and he gives his approval or disapproval of any land transactions for the minors.

Wilbur Wilkinson is the Credit Officer. He handles small loans, corporation loans, IPB grants and mortgages.

John Danks is the director for all reservation programs. The programs are plant management, housing and roads. Maintenance and construction is directed under the B.I.A. Mr. Sevalson the director for plant management. Funding is very limited for roads. New material has been tried on the roads and works just as good as pavement. It will only be used on segment roads, not main highways. Pete Star is the H.I.P. director. Mr. Danks also handles the 93-638 contracts. Clyde Baker is the director for alcoholism. He stated that it is the number one (1) problem. He runs the Halfway House in New Town and staffs five (5) people. The Halfway House is always open to anyone. Mr. Baker stated that he hoped the Tribal Business Council will recognize the Alcoholism Program. And there is one representative from each segment to serve on the Board of Directors. There are two (2) mobile units on the reservation to serve as a treatment center. People are sent to Ft. Meade, Minot, Sheridan and Jamestown for treatments.

Nell Boozenny is the director of the C.A.P. program. The manager of winterization is Orville Mandan. The applications are reviewed by the H.I.P. program. To qualify for winterization, a home must be owned by an individual. C.A.P. also takes care of community organization planning and on the job training. Roberta Young Bird takes care of the Aging Services.

Chairperson Rose Crow Flies High has taken this time to introduce her whole council members to all the directors present.

Lunch break from 12:00 p.m. to 1:30 p.m.

After lunch, the meeting continued with the directors explaining the purpose of their program and how they are funded.

Eight in favor and none opposed. Motion carried.

Ronald Little Owl moved that Carl Whitman, Jr.'s trip be authorized in resolution form to Denver, Colorado, seconded by Eva Beaks. Roll call vote: Hazel Blake, Eva Beaks, Ralph Bird Bear, Wayne Packineau, Thomas Eagle, Jr., Ronald Little Owl, Roy Bird Bear and Larry Rush, yes. Chairperson not voting. Eight in favor and none opposed. Motion carried.

Roll call vote: Hazel Blake, Eva Beaks, Ralph Bird Bear, Wayne Packineau, Thomas Eagle, Jr., Ronald Little Owl, Roy Bird Bear and Larry Rush, yes. Chairperson not voting. Eight in favor and none opposed. Motion carried.
