Meeting came to order at 1:30 PM.

Roll call - Quorum present.

Opening prayer by Chaplain, Bill Lockwood.

Eugene Voight was given the floor.

Mr. Voight stated that they have appealed to the Indian Commissioner of a lease that was denied to Duane Charging, and that they are asking support from the Tribal Council.

Austin Gillette arrived at 2:55 PM.

Larry moved to support Duane and Kenneth Charging, and that no money should be paid out regardless of who deposits. Second by Eva. Roll call vote: Roy Bird Bear, Larry Rush, Thomas Eagle, Jr., Theodore Bird Bear, Eva Beaks, Austin Gillette, Wayne Packineau, Hazel Blake - yes. Eight in favor, none opposed. Chairman voting. Motion carried.

Acting Superintendent, Don Morgan reported on the interviews of Special Officers. One Mr. Gilham has withdrawn his application for this position. Austin moved to hire Homer White Buffalo. Second by Thomas *Eagle*.

Thomas Eagle, Jr. and Austin Gillette - no. Wayne Packineau - abstain. Six in favor, two opposed, one abstention. Chairman voting. Motion carried.

Theresa and Debbie Danks' land exchange.
Thomas moved to approve, provided Tribe partitions first.
Second by Roy Bird Bear. Roll call vote: Larry Rush, Roy
Bird Bear, Thomas Eagle, Jr., Theodore Bird Bear, Austin
Gillette, Wayne Packineau - yes. Eva Beaks - abstain.
Hazel Blake - no. Six in favor, one opposed, one abstention.
Chairman not voting. Motion carried.

Kenneth Fredericks land exchange.
Thomas moved to approve. Second by Wayne. Roll call vote:
Roy Bird Bear, Thomas Eagle, Jr., Theodore Bird Bear, Austin
Gillette and Wayne Packineau - yes. Eva Beaks, Hazel Blake,
Larry Rush and Rose Crow Flies High - no. Five in favor,
four opposed. Chairman voting. Motion carried.

Thomas Eagle, Jr. brought up the delinquent payments on Joe Meyers loan. Insurance is due now. Thomas moved that the Credit Committee look into this and give their recommendations to the council. Second by Eva. Six in favor, one abstention. Motion carried.

Larry Burr recommends that the Tribe set up some kind of rates on farm leases. To set up a schedule.

Thomas Eagle, Jr. moved to adjourn the meeting. Second by Roy Bird Bear.
